INVITATION TO BID FOR THE PROCUREMENT OF PICK-UP VEHICLES FOR THE CONVERGENCE ON VALUE CHAIN ENHANCEMENT FOR RURAL GROWTH AND EMPOWERMENT (CONVERGE) PROJECT Re-bid

1. The Government of the Philippines (GOP) has received a loan from the International Fund for Agricultural Development (IFAD), and intends to apply part of the proceeds of this loan with a counterpart from the GOP in the amount of Seventeen Million Nine Hundred Seventy-One Thousand Pesos only (PhP17,971,000.00) being the Approved Budget for the Contract (ABC), for the Procurement of Pick-up Vehicles for the Convergence on Value Chain Enhancement for Rural Growth and Empowerment (ConVERGE) Project, broken down into two (2) lots, as follows:

Bids received in excess of the ABC shall be automatically rejected at bid opening.

- 2. The Department of Agrarian Reform (DAR) now invites bids for the supply and delivery of 4x4 and 2x2 pick-up vehicles for mobility support during the implementation of the Project. Delivery of the Goods is required on or before thirty (30) calendar days after supplier's receipt of the Notice to Proceed.
 - Bidders should have completed, within the last five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
- 4. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 5. Interested bidders may obtain further information from the DAR-BAC and inspect the Bidding Documents at the address given below during Mondays to Fridays, 8:00 a.m. to 5:00 p.m.

- 6. A complete set of Bidding Documents may be acquired by interested Bidders starting February 10, 2017 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount indicated in paragraph 1 above. Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 7. The DAR-BAC will hold a Pre-Bid Conference on **February 20, 2017** at the FAPsO Conference Room, DAR Compound, Elliptical Road, Diliman, Quezon City at **10:00 a.m.** which shall be open to prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat at the address below on or before March 7, 2017, 9:00 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
 - Bid opening shall be on March 7, 2017, 10:00 a.m. at the FAPsO Conference Room, DAR Compound, Elliptical Road, Diliman, Quezon City. Bids will be opened in the presence of the bidders' representatives who choose to attend. Late bids shall not be accepted.
- 9. The DAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
