BAC Resolution No. 12 Series of 2017

"RESOLUTION RECOMMENDING THE PROCUREMENT by DIRECT CONTRACTING of IDEYATECH INC. for the SYSTEM DEVELOPER MAINTENANCE and SUPPORT of LEGAL CASE MANAGEMENT SYSTEM (LCMS)

WHEREAS, the DAR, through the Legal Affairs Office (LAO) adopted and used the web-based Legal Case Management System (LCMS), the licensed software which was procured in CY 2011 and the enhancement for the system in CY 2013, to ensure the efficient capture and central storage of legal case records;

WHEREAS, the DAR entered into a Memorandum of Agreement through Direct Contracting with IDEYATECH, Inc, for the procurement of the licensed software and LCMS implementation in September 2011 and the enhancement of the system in 2013;

WHEREAS, DAR has been issued an Attache License Certificate, which granted the Department with a Multi-instance Perpetual usage license for the Attache Magnus;

WHEREAS, to ensure the continued and effective performance of the system, the end-user proposed for the provision of second level application support, maintenance and enhancement of the LCMS for one year and access to trainings and updating of training materials, as reflected in the CY 2017 APP;


WHEREAS, the End-User, Management Information System Service (MISS) presented certifications that IDEYATECH, Inc. is the sole creator, developer and authorized distributor of Attache in the Philippines, trademark of which is registered with the IP PHL and copyright with the National Library of the Philippines;

WHEREAS, the End-user recommended to procure the LCMS maintenance and support system through Direct Contracting IDEYATECH Inc., the exclusive distributor which does not have sub-dealers that could offer a lower price and for which no suitable substitute can be obtained at a more advantageous terms to the government, pursuant to Sect. 50.c of the 2016 Revised IRR of RA 9184;

WHEREFORE, premises considered, the BAC resolves to recommend to the Head of the Procuring Entity (HoPE) , the approval of procurement by Direct Contracting for the second level application support, maintenance and system enhancement of the LCMS for one year in the total amount of ONE MILLION SIX HUNDRED THOUSAND PESOS (Php 1,600,000.00).
