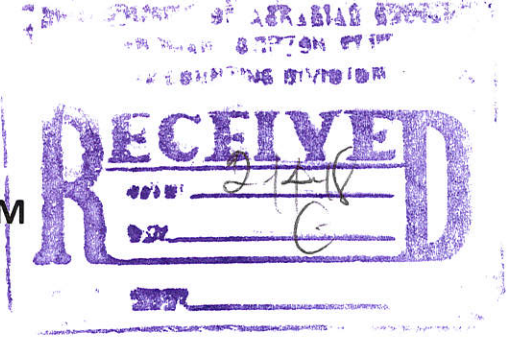

CONTRACT : JANITORIAL SERVICES FOR CY 2018 TO LAGING QLEAN JANITORIAL SERVICES, INC.

REFERENCE : DAR BAC Resolution No. 30 series of 2017

CONTRACT AGREEMENT

THIS AGREEMENT made this ___ day of January 2018 between the **Department of Agrarian Reform (DAR)** of Elliptical Road, Diliman, Quezon City, Philippines, (hereinafter called "the Procuring Entity"), of the one part and **Laging Qlean Janitorial Services, Inc.**, of 626 G. Araneta Avenue, Quezon City, (hereinafter called "the Service Provider") of the other part:

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, viz., Janitorial Services for DAR Central Office for CY 2018 (January 1 to December 31, 2018) and has accepted a Bid by the Service Provider for the supply of janitorial services in the sum of **Philippine Pesos Twenty Million Three Hundred Eighty Seven Thousand Nine Hundred Fifty and 92/100 (Php 20,387,950.92)** for eleven (11) months commencing February 1, 2018 (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (A) Laging Qlean Janitorial Services, Inc. Bid, Eligibility Requirements, Technical and Financial Proposals;
- (B) the Schedule of Requirements;
- (C) the Technical Specifications;
- (D) the General Conditions of the Contract;
- (E) the Special Conditions of the Contract;
- (F) the Performance Security;
- (G) the Procuring Entity's Notice of Award.

3. In consideration of the payments to be made by the Procuring Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Procuring Entity to provide janitorial services for CY 2018 and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Procuring Entity hereby covenants to pay the Service Provider in consideration of the provision of janitorial services for CY 2018 and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the

time and in the manner prescribed by the contract. In case of delays in the delivery/performance of the required services specified in this Contract due to the Service Provider's fault, the Procuring Entity shall deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one percent of the cost of the unperformed portion for every day of delay until actual delivery or performance. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum is reached, the Procuring Entity may rescind the contract pursuant to GCC Clause 23, without prejudice to other courses of action and remedies open to it.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


