The engagement shall support the implementation of its micro-finance scheme during an estimated period of 36 man-months with the following duties: a. facilitate the improvement of credit access for target beneficiaries; b. assist in the expansion of credit worthy farmers; c. introduce and pilot Shari'ah compliant financial projects and products in the Muslim areas; d. improve policies encouraging financial inclusion of the poor; e. introduce additional financial services available to the farmer beneficiaries (e.g. micro-agri loan, micro-credit, micro-saving, micro-insurance, micro-guarantee, women financial inclusion); f. foster self-employment as a means for socio-economic progress and not simply as a means for survival from poverty; and, g. implement a sustainable micro-finance mechanism.

# CONDITIONS OF PARTICIPATION

## 11. Eligibility

Participation in tendering is open on legal persons (participating either individually or in a grouping – consortium - of tenderers) which are established in Italy.

## 12. Candidature

All eligible legal persons (as per item 11 above) or groupings of such persons (consortia) may apply.

A consortium may be a permanent, legally-established grouping or a grouping which has been constituted informally for a specific tender procedure. All members of a consortium (i.e., the leader and all other members) are jointly and severally liable to the Contracting Authority.

The participation of an ineligible natural or legal person (as per item 11) will result in the automatic exclusion of that person. In particular, if that ineligible person belongs to a consortium, the whole consortium will be excluded.

# 13. Number of applications

No more than one application can be submitted by a legal person whatever the form of participation (as an individual legal entity or as leader or member of a consortium submitting an application). In the event that a legal person submits more than one application, all applications in which that person has participated will be excluded.

## 14. Shortlist alliances prohibited

Any tenders received from tenderers comprising firms other than those mentioned in the short-listed application forms will be excluded from this restricted tender procedure unless prior approval from the Contracting Authority has been obtained (see Practical Guide – PRAG - 2.4.3.). Short-listed candidates may not form alliances or subcontract to each other for the contract in question.

# 15. Grounds for exclusion

As part of the application form, candidates must submit a signed declaration, included in the standard application form, to the effect that they are not in any of the exclusion situations listed in Section 2.3.3 of the PRAG. Candidates must also submit a self-declaration in compliance with Presidential Decree n. 445/2000 concerning the Antimafia certificate as per legislative decree n. 159/2011.

# 16. Sub-contracting

Subcontract is allowed up to an amount of 30% of the total contract amount. Upon submitting their bids, bidders must declare which services they intend to subcontract. Contractors must deposit subcontracts with the contracting authority at least 20 days before commencing the execution of the subcontracts. Subcontractors must be eligible for the services they are assigned.

# SELECTION AND AWARD CRITERIA

# 21. 1. Selection criteria

The following selection criteria will be applied to candidates. In the case of applications submitted by a consortium, these selection criteria will be applied to the consortium as a whole unless specified otherwise. The selection criteria will not be applied to natural persons and single-member companies when they are sub-contractors.

For exclusion criteria we refer to the provision of Annex 2 of the MOU signed between the Government of the Italian Republic and the Government of the Republic of Philippines

1) Economic and financial capacity of candidate (based on item 3 of the application form). In case of candidate being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last three years for which accounts have been closed.

The total turnover of the candidates/bidders in the last three years should be virtually equivalent to the maximum budget of the contract; enterprises that have been established for less than three years should have an annual turnover equal to one third of the total amount of the contract.

Criteria 1.1 - ratio turnover/contract budget should equal 1

Criteria 1.2 – ratio current asset/liabilities three years average at least 0.5

- 2) <u>Professional capacity of candidate</u> (based on items 4 and 5 of the application form). The reference period which will be taken into account will be the last three years from submission deadline.
  - Criteria 2.1 3 long term staff currently work for the candidates in field related to this contract
  - Criteria 2.2 Candidate has as main field of specialization micro-finance or cooperative financing
- 3) <u>Technical capacity of candidate</u> (based on items 5 and 6 of the application form). The reference period which will be taken into account will be the last three years from submission deadline.

The candidate has provided similar services at least under one contract in the last three years of activity. On-going contract is considered valid to this purpose.

Criteria 3.1 – total number of similar contracts

Criteria 3.2 - total consolidated budget managed for similar contracts

Previous experience which caused breach of contract and termination by a Contracting Authority shall not be used as reference.

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with

them. It must in that case prove to the Contracting Authority that it will have at its disposal the resources necessary for performance of the contract, for example by producing a commitment on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility - notably that of nationality – and must fulfil the same relevant selection criteria as the economic operator. With regard to technical and professional criteria, an economic operator may only rely on the capacities of other entities where the latter will perform the works or services for which these capacities are required. With regard to economic and financial criteria, the entities upon whose capacity the tenderer relies, become jointly and severally liable for the performance of the contract.

If more than 8 eligible candidates meet the above selection criteria, the relative strengths and weaknesses of the applications of these candidates must be reexamined to identify the eight best candidates. The only factors which will be taken into consideration during this re-examination in priority order are:

- 1) Criteria 3.1 highest number of similar contracts
- 2) Criteria 1.1 highest ratio of turn over
