BAC RESOLUTION RECOMMENDING AWARD OF CONTRACT TO R.U. FOUNDRY AND MACHINE SHOP CORPORATION FOR LOT 1, LOT 2 AND LOT 4, FOR THE SUPPLY, DELIVERY AND INSTALLATION OF SOLAR-POWERED IRRIGATION SYSTEM FOR THE CLIMATE RESILIENT FARM PRODUCTIVITY SUPPORT PROJECT OF THE DEPARTMENT OF AGRARIAN REFORM (REFERENCE NO. PBD-18-06)

WHEREAS, the Department of Agrarian Reform (DAR), under the General Appropriations Act (GAA) of 2018, intends to apply the sum of Philippine Pesos Eighty-Six Million Seven Hundred Fifty-Three Thousand Two Hundred Fifty Only (Php86,753,250.00) inclusive of taxes, being the Approved Budget for the Contract (ABC) for the supply, delivery and installation of 101 units of solar-powered irrigation system, broken down into five (5) lots for the Climate Resilient Farm Productivity Support Project to its designated provincial offices, (refer to Annex A, BAC Resolution No. 29, series of 2018, Recommending Bid Failure for Lots 3 and 5 of PBD-18-06);

WHEREAS, on December 13, 2018, upon instructions of the Bids and Awards Committee (BAC)-Primary, the BAC-Technical Working Group (TWG) with the BAC Secretariat staff visited the sites where the 2nd Lowest Calculated Bid (LCB) for Lot 1, Lot 2 and Lot 4, R.U. Foundry and Machine Shop Corporation (R. U. Foundry), has already installed similar solar-powered irrigation systems, to possibly assess the quality of their performance. After thorough inspection and inquiries in relation to the technical specifications, the BAC-TWG could attest to the veracity of R.U. Foundry's statement of compliance in Section VII. Technical Specifications, (refer to Annex B, Statement of Compliance as signed by the authorized representative);

WHEREAS, on December 14, 2018, the BAC-TWG presented the results of post-qualification to the BAC-Primary, and after a series of queries on how the actual inspection of the systems during site visitations went on, the BAC-Primary found the results to be satisfactory and thus, declared R.U. Foundry to be the Lowest Calculated Responsive Bidder (LCRB) for Lot 1, Lot 2 and Lot 4, (refer to Annex C, Post-Qualification Report);

WHEREFORE, premises considered and upon recommendation by the BAC-TWG, the BAC-Primary resolves to recommend to the Head of the Procuring Entity (HoPE), the award of contract to R. U. FOUNDRY AND MACHINE SHOP CORPORATION for Lot 1, Lot 2 and Lot 4, as follows:
