pursuant to the latest Guidelines issued by the GPPB, in the amount of PhP2,500.00. Bidding Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 7. The DAR-Bids and Awards Committee-Primary, will hold a Pre-Bid Conference on February 26, 2019 at 10:00 a.m. at the FAPsO Conference Room, DAR Central Office, Elliptical Road, Diliman, Quezon City, which shall be open to all prospective bidders.
- 8. Bids must be duly received by the BAC Secretariat at the address below on or before March 11, 2019 at 9:00 a.m. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on March 11, 2019 at 10:00 a.m. at the FAPsO Conference Room, DAR Central Office, Elliptical Road, Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

The Department of Agrarian Reform reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
