**SERVICE CONTRACT**

**THIS AGREEMENT** executed this 15<sup>th</sup> day of July 2019 between the **Department of Agrarian Reform Regional Office MiMaRoPa (DARRO-MiMaRoPa)**, located at MiMaRoPa Building, DAR Compound, Elliptical Road, Diliman, Quezon City, Philippines, referred to as the **Procuring Entity**, represented by its Regional Director, **EUGENE P. FOLLANTE** and **TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC.**, with office address at G/F, Cavite Coliseum, Aguinaldo Hi-way, Bacoor City, Cavite, referred to as the **Service Provider** represented by herein President **LAMBERTO G. MERCADO**.

**WHEREAS**, the **Procuring Entity** needed the services of a competent and efficient security agency for CY 2019 from July 1 to December 31, 2019;

**WHEREAS**, an open and competitive bidding was conducted on the 2<sup>nd</sup> day of July 2019 wherein the Service Provider emerged as the Single Calculated Responsive Bid for the provision of security services in CY 2019;

**WHEREAS**, the Procuring Entity has decided to award the contract for security services for the period July 1, 2019 to December 31, 2019 to **Tough Guard Security and Investigation Agency, Inc.**


**NOW THEREFORE THE PARTIES HEREBY AGREED AS FOLLOWS:**


1. The Procuring Entity will pay the Service Provider the sum of **PHILIPPINE PESOS One Million Three Hundred Twenty-Two Thousand Fourteen Pesos and 86/100 (PHP 1,322,014.86)** inclusive of all taxes (hereinafter called "the Contract Price") for the manpower security services;
2. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of the Contract;

4. In consideration of the payments to be made by the Procuring Entity to the Service Provider, the Service Provider undertakes to provide the services and remedy defects in conformity with the provisions of the Contract.

This Contract and the Annexes set forth the entire agreement between the parties pertaining to the services described and supersedes any and all earlier verbal or written agreements pertaining to the services.


