RESOLUTION NO. 36 SERIES OF 2019

RESOLUTION RECOMMENDING FAILURE OF BIDDING FOR THE PROCUREMENT OF E-LEARNING COURSEWARE FOR THE SUPERVISORY DEVELOPMENT PROGRAM FOR DAR MUNICIPAL AGRARIAN REFORM PROGRAM OFFICERS (MARPOs) AND DIVISION CHIEFS (DCs)

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos One Million Four Hundred Eighty Four Thousand Six Hundred Thirty and 22/100 only (P1,484,630.22) being the Approved Budget for the Contract (ABC), for the procurement of E-Learning Courseware for the Supervisory Development Program, for DAR MARPOs and DCs (refer to Annex "A" copy of approved project proposal);

WHEREAS, on September 13, 2019, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC-P) posted the Invitation to Bid in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6468482 (refer to Annex "B", copy of PhilGEPS posting);

WHEREAS, on September 23, 2019, the BAC-Primary conducted a pre-bidding conference attended by the following prospective bidders: 1) Yapster E-Learning, Inc.; and 2) Vibal Group, Inc., to clarify the provisions of the bidding documents and reiterate the general requirements of the procurement at hand;

WHEREAS, on September 30, 2019, the BAC-Primary issued Supplemental Bid Bulletin No. 1 to respond to queries raised by a bidder regarding the Bid Forms, Price Schedules and Statement of Single Largest Completed Contract (SLCC) (refer to Annex "C" copy of SBB No. 1);

WHEREAS, on October 7, 2019, the scheduled deadline of submission and opening of bids, two (2) bidders submitted their bids namely: 1) Yapster E-Learning, Inc., and 2) Trust Management Centre. However, only the bid of Yapster E-Learning, Inc. was accepted for opening because Trust Management Centre failed to pay for the bidding documents fee prior to the deadline for bid submission as provided for in the Invitation to Bid and in clause 6.8 of the Instructions to Bidders;

WHEREAS, upon opening of the bids of Yapster E-Learning, Inc., it was found that said bidder submitted one original and one copy of the technical and financial components of its bid and failed to comply with the number of copies required under ITB clause 20.3 in the Bid Data Sheet which is one


original and four (4) copies of both the technical and financial components (refer to Annex "D" copy of Abstract of Bids);

NOW THEREFORE, premises considered, and due to the disqualification of the bid of Yapster E-Learning, Inc. being the sole bidder, the BAC-Primary resolved to recommend to the Head of the Procuring Entity (HOPE), the following:

1. Declaration of failure of bidding; and
2. The conduct of rebidding for the subject procurement.


