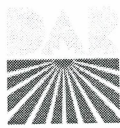

INVITATION TO BID (ITB)

The Department of Agrarian Reform-Cordillera Administrative Region (DAR-CAR) Regional Office, through the Government of the Philippines General Appropriation Act of 2019, intends to apply the sum of **Seven Hundred Eighty Thousand Pesos (Php 780,000.00) Only** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Climate Resilient Farm Productivity Support Project - Provision of Greenhouse Structure with Installation and Other Implements**. Bids received in excess of the ABC shall be automatically rejected in accordance with Section 31.1 of the Revised IRR of RA 9184 at bid opening.
2. The DAR-CAR now invites bids for the following items:

3. Delivery of the Goods specified above shall be within 60 calendar days from receipt of the Notice to Proceed (NTP). Bidders should have completed, within Three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders (ITB).
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Interested bidders may obtain further information from DAR-CAR Regional Special Bids and Awards Committee (RSBAC) Secretariat and inspect the Bidding Documents at the DAR-CAR Regional Office with address at No. 39 Rebolledo Bldg., Alfonso Tabora Barangay, M.
