**DECLARING FAILURE OF BIDDING FOR LOT 2 (PROVISION OF GREENHOUSE WITH INSTALLATION AND OTHER IMPLEMENTS) AND RECOMMENDING FOR SECOND POSTING TO PHILGEPS**

**WHEREAS**, the DEPARTMENT OF AGRARIAN REFORM-CORDILLERA ADMINISTRATIVE REGION (DAR-CAR) through the SPECIAL BIDS AND AWARDS COMMITTEE (SBAC) advertised the Invitation to Bid for the Procurement of Climate Resilient Farm Productivity Support Project (CRFPSP) for CY 2019 through an advertisement in the Philippine Government Electronic Procurement Service (PhilGEPS) on July 14, 2019 with an Approved Budget for the Contract (ABC) amounting to **Fourteen Million One Hundred Fifty Seven Thousand Five Hundred Pesos (Php 14,157,500.00)** which was divided into two lots; Lot 1 – Farm Machinery and Equipment/Implement with an ABC of **Thirteen Thousand Three Hundred Seventy Seven Thousand Five Hundred Pesos (Php 13,377,500.00)** and Lot 2 - Provision of Green House Structure with Installation and Other Implements with an ABC of **Seven Hundred Eighty Thousand Pesos (Php 780,000.00)**;


**WHEREAS**, on the scheduled deadline for the Submission on 09 August 2019 at 12:00, no bids were received for Lot 2 (Provision of Greenhouse Structure with Installation and Other Implements);

**NOW, THEREFORE**, we, the Members of the Regional Special Bids and Awards Committee, hereby **RESOLVED** as it is hereby **RESOLVED**:

1. To declare a failure of bidding for Lot 2 for the reason that no bids were received.
2. To repost Lot 2 (Provision of Greenhouse Structure with Installation and Other Implements) for the second time.


