SUBJECT : AMENDING MEMORANDUM CIRCULAR NO. 10 SERIES OF 1993, RE: AMENDMENTS ON THE GUIDELINES ON THE PREQUALIFICATION, PUBLIC RAFFLE AND AWARD OF CARP MODULE SURVEY CONTRACTORS AND TERMS AND CONDITIONS OF THE CONTRACT.

The third paragraph of Memorandum Circular No. 10 Series of 1993 is hereby amended to read as follows:

"The performance bond required in H.1.1 of the same Memorandum Circular, may be obtained not only from the GSIS, but also from any other duly registered and reputable insurance company duly accredited by the Insurance Commission"

This circular shall take effect immediately and supersedes or modifies all orders, circulars, memorandum and other issuances inconsistent herewith.

With reference to Memorandum Circular #10, s. 1993 issued by that Office amending certain provisions of MC #6, s. 1993 re: Guidelines on the Prequalification, Public Raffle and Award of CARP Module Survey Projects, this Office would like to call your attention to the third paragraph alluded thereto, which states:

"The performance bond required in H.1.1. of the same Memorandum Circular, may be obtained not only from the GSIS but also from any other duly registered and reputable insurance company."

COA regulation requires the posting of performance bond with the GSIS (COA Circular 79-112 dated August 30, 1979) however, with regards to bonds obtained from insurance companies other than the GSIS, such insurance companies must not only be duly registered and reputable but must also be duly accredited by the Insurance Commission.

SUBJECT: AMENDING CERTAIN PROVISIONS OF MEMORANDUM CIRCULAR NO. 6, SERIES OF 1993, RE: GUIDELINES ON THE PREQUALIFICATION, PUBLIC RAFFLE AND AWARD OF CARP MODULE SURVEY PROJECTS; INSTRUCTIONS TO PROSPECTIVE SURVEY CONTRACTORS AND TERMS AND CONDITIONS OF THE CONTRACT


 To ensure the immediate conduct of survey activities, Provincial Agrarian Reform Officers may be authorized in writing, at the discretion of the Undersecretary for Field Operations and Support Services or of the Regional Director concerned, to perform the functions/activities of the Regional Director, provided under item Nos. D.1, E.2, G.1, G.2, H.1, H.1.1, 1.2, I.6, I.7, I.8, K.3, L and M of Memorandum Circular No. 6, Series of 1993, for their respective province.

In line with the said authorization, the prequalification forms and other related/papers/forms, per Item No. C.1; posting of Notices of Public Raffle, per Item No. E.1; listing of module survey projects per Item No. E.2; conduct of public raffles, per Item E; and awarding of module survey projects, per Item G which are performed in the DAR Regional Office per said Memorandum Circular may now be made available and undertaken at the Provincial Agrarian Reform Office (DARPO).

The performance bond, required in H.1.1 of the same Memorandum Circular, may be obtained not only from the GSIS, but also from any other duly registered and reputable insurance company. *duly approved by the Administrative Commission.*

This Order shall take effect immediately and supersedes or modifies all orders, circulars, memoranda and other issuances inconsistent herewith.
