RESOLUTION NO. 51 SERIES OF 2019

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF E-LEARNING COURSEWARE FOR THE SUPERVISORY DEVELOPMENT PROGRAM FOR DAR MUNICIPAL AGRARIAN REFORM PROGRAM OFFICERS (MARPOs) AND DIVISION CHIEFS (DCs) TO YAPSTER E-LEARNING INC.

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos One Million Four Hundred Eighty Four Thousand Six Hundred Thirty and 22/100 only (₱1,484,630.22) being the Approved Budget for the Contract (ABC), for the procurement of E-Learning Courseware for the Supervisory Development Program, for DAR MARPOs and DCs (refer to Annex "A" copy of approved project proposal);

WHEREAS, on October 7, 2019, the scheduled deadline of submission and opening of bids, two (2) bidders submitted their bids namely: 1) Yapster E-Learning, Inc., and 2) Trust Management Centre, but only the bid of Yapster E-Learning, Inc. was accepted for opening because Trust Management Centre failed to pay for the bidding documents fee prior to the deadline for bid submission as provided for in the Invitation to Bid and in clause 6.8 of the Instructions to Bidders. Upon opening of the bids of Yapster E-Learning, Inc., it was found that said bidder submitted only one original and one copy of the technical and financial components of its bid and failed to comply with the number of copies required under ITB clause 20.3 in the Bid Data Sheet which is one original and four (4) copies of both the technical and financial components, thus, it was disqualified and the BAC declared a failure of bidding and recommended a re-bid thru BAC Resolution No. 36 series of 2019 (refer to Annex "B" copy of BAC Resolution);

WHEREAS, on October 19, 2019, the Department of Agrarian Reform-Bids and Awards Committee (DAR-BAC) posted the Invitation to Bid (rebid) (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6569887 (refer to Annex "C" copy of PhilGEPs posting);

WHEREAS, on November 11, 2019, the deadline for submission and opening of bids, only one bidder, **Yapster E-Learning, Inc.** submitted its bid in the amount of **Philippine Pesos One Million Two Hundred Eighty Nine Thousand Four Hundred Forty Two and 25/100 only (PhP1,289,442.25)**, was found eligible and compliant to the technical document submission requirements, and was evaluated to have complied with the requirements of the bidding documents, thus declared as the Single Calculated Bidder (SCB) to be subjected to post-qualification (refer to Annex "D" Detailed Bid Evaluation Report);

WHEREAS, on November 13, 2019, a Notice of Post-qualification was sent to the SCB after which a post-qualification evaluation was undertaken by the BAC-Technical Working Group (TWG) on November 18, 2019 (refer to Annex "E" Notice of Post-Qual);

WHEREAS, on November 19, 2019, during the BAC-Primary meeting, the TWG reported its post-qualification evaluation findings on the SCB and based on the report, the SCB was found to be responsive to all the requirements of the bidding documents and with the BAC's confirmation, the SCB was declared as the Single Calculated Responsive Bidder (SCRB) (refer to Annex "F" Post-qualification Evaluation Report);

NOW THEREFORE, premises considered, the BAC resolved to recommend to the HOPE the award of contract to the Single Calculated and Responsive Bidder (SCRB), **Yapster E-Learning, Inc.** for the supply and delivery of E-Learning Courseware for the Supervisory Development Program for DAR Municipal Agrarian Reform Program Officers (MARPOs) and Division Chiefs (DCs) in the total amount of **Philippine Pesos One Million Two Hundred Eighty Nine Thousand Four Hundred Forty Two and 25/100 only (PhP1,289,442.25)**, inclusive of taxes.
