BAC Resolution Declaring the Failure of Bidding for the Procurement of Motor Vehicle (Pick-up) and Recommending to the Head of the Procuring Entity (HOPE) for Second Posting to PhilGEPs

**BAC RESOLUTION NO. 239
Series of 2019**

WHEREAS, the DEPARTMENT OF AGRARIAN REFORM- CORDILLERA ADMINISTRATIVE REGION (DAR-CAR) through the BIDS AND AWARDS COMMITTEE advertised the Invitation to Bid for the Procurement of Motor Vehicle (Pick-up), through an advertisement in the Philippine Government Electronic Procurement Service (PhilGEPs) and at a conspicuous place within the premises of the DAR-CAR Regional Office on November 27, 2019 with a total Approved Budget for the Contract (ABC) amounting to One Million Seven Hundred Thousand Pesos (Php 1,700,000.0);

WHEREAS, the Invitation to Bid was posted at the DAR-CAR Regional Office Bulletin Board located at the Second Floor at No. 39 Rebolledo Building, Alfonso Tabora Barangay, M. Roxas St., Baguio City (Please see Annex "A");

WHEREAS, the Invitation to Bid was posted at the Official Website of the Department of Agrarian Reform – Central Office;

WHEREAS, in response to said advertisement, there was only one (1) Bidder. The Motor Plaza, Inc. who purchased the bid documents and submitted its eligibility requirements, technical and financial proposal on December 17, 2019;

WHEREAS, during the opening of the eligibility, technical and financial documents on December 18, 2019, Motor Plaza, Inc. failed to submit more than two items in the eligibility checklist required pursuant to RA 9184;

WHEREAS, as per evaluation, it was determined that the bid of Motor Plaza, Inc. was found to be ineligible and non-compliant with the requirements;

NOW THEREFORE, we, the members of the BAC hereby resolve:

1. To declare First Failure of bidding for the Procurement of Motor Vehicle (Pick-up);
2. To recommend to the Head of the Procuring Entity (HOPE) the approval of the Second Posting for the Procurement of Motor Vehicle (Pick-up).
