### RESOLUTION RECOMMENDING FAILURE OF BIDDING FOR THE PROCUREMENT OF CONSULTING SERVICES FOR THE CONDUCT OF IMPACT ASSESSMENT STUDY FOR THE AGRARIAN REFORM INFRASTRUCTURE SUPPORT PROJECT PHASE III (ARISP III)

**WHEREAS**, the Department of Agrarian Reform Central Office, through the Project Management Service intends to apply the sum of Philippine Pesos Three Million only (₱3,000,000.00) being the Approved Budget for the Contract (ABC) chargeable under the CY 2018 General Appropriations Act (GAA), for the procurement of Consulting Services for the Conduct of Impact Assessment Study for the Agrarian Reform Infrastructure Support Project Phase III (ARISP III);

**WHEREAS**, on November 27, 2019, the BAC-Primary recommended and the Head of the Procuring Entity (HOPE) approved the result of the shortlisting of bidders for the abovementioned procurement (refer to **Annex "A"**, BAC Resolution No. 60 series of 2019;

**WHEREAS**, on November 29, 2019, the two (2) shortlisted bidders were sent the Request for Proposals with the schedule of Pre-bidding Conference on December 6, 2019 and the deadline for submission on December 18, 2019 at 10:00 a.m.(refer to **Annex "B"** copy of notices sent to shortlisted bidders);

**WHEREAS**, on December 13 and 17, 2019, the Asian Social Project Services, Inc. and CPRM Consultants, Inc., respectively, sent letters of regret to the BAC Chairperson as both cannot submit proposals because the Approved Budget for the Contract (ABC) is insufficient compared to the scope of the study (refer to **Annex "C"** letters from the 2 short listed bidders);

**WHEREFORE**, premises considered, the BAC resolves to recommend to the Head of Procuring Entity (HOPE) the declaration of failure of bidding and the conduct of mandatory review, and/or revision of the Terms of Reference (TOR) and


Approved Budget for the Contract (ABC) prior to the conduct or rebid, if any.






