### RESOLUTION RECOMMENDING THE AWARD OF THE CY 2020 CONTRACT FOR JANITORIAL SERVICES FOR THE PERIOD FEBRUARY 1- DECEMBER 31, 2020 TO LAGING QLEAN JANITORIAL SERVICES, INC.

**WHEREAS**, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2020 intends to apply the sum of Philippine Pesos Twenty Two Million Seven Hundred Seventy Seven Thousand Seven Hundred Seventy Six and 41/100 only (PhP 22,777,776.41) being the Approved Budget for the Contract (ABC), for the procurement of Janitorial Services for CY 2020 (refer to **Annex "A"** copy of approved project proposal);

**WHEREAS**, on November 23, 2019, the Bids and Awards Committee-Primary (BAC) posted the Invitation to Bid for the procurement of Janitorial Services for the DAR Central Office for CY 2020 at the DAR website, DAR bulletin board, and the PhilGEPs website with reference number 6689086 (refer to **Annex "B"**, copy of PhilGEPs posting);

**WHEREAS**, during the deadline for submission of bids on December 16, 2019, at 11:00 AM, only one (1) bidder, Laging Qlean Janitorial Services, Inc. submitted its bid in the total amount of Philippine Pesos Twenty Two Million Seven Hundred Seventy Seven Thousand Five Hundred Ninety Six and 80/100 (₱ 22, 775, 596.80) for twelve (12) months (January 1-December 31, 2020) which was declared as the Single Calculated Bidder (SCB) (refer to **Annex "C"**, Abstract of Bids) ;

**WHEREAS**, on December 16, 2019, during the BAC meeting, the end-user representative recommended the extension of the 2019 Janitorial Services contract for one (1) month for January 1-31, 2020, due to time constraints and since the GAA for CY 2020 is not yet approved (refer to BAC Resolution No. 67, series of 2019);


**WHEREAS**, the BAC-TWG convened for detailed evaluation on January 8, 2020 and recommended to the BAC-Primary on January 10, 2020 the post-qualification evaluation of the SCB, Laging Qlean Janitorial Services, Inc.


**WHEREAS**, the BAC-TWG reported to the BAC on January 17, 2020 that the SCB passed post-qualification evaluation and recommended the award of contract to

the Single Calculated Responsive Bidder (SCRB), (refer to **Annex "D"**, Detailed Evaluation and Post-qualification Report);


**WHEREFORE**, premises considered, the BAC resolved in its meeting on January 17, 2020 to recommend to the Head of the Procuring Entity (HOPE), the award of the contract for **CY 2020 Janitorial Services to Laging Qlean Janitorial Services, Inc.** for the period from **February 1, 2020 to December 31, 2020**, in the total amount of **Philippine Pesos Twenty Million Eight Hundred Seventy Seven Thousand Six Hundred Thirty and 40/100 (₱20,877,630.40)**, inclusive of taxes.






