CONTRACT AGREEMENT

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, viz., Procurement of Lease of Brand New Photocopying Machines and has accepted a Bid by the Service Provider for the supply and delivery of fifty five (55) units of Brand New Photocopying Machines for eleven (11) months for the period February 1, 2020 to December 31, 2020, in the sum of Philippine Pesos Three Million Nine Hundred Eighty Seven Thousand Five Hundred (\$\P\$3,987,500.00) inclusive of all applicable taxes (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

3. In consideration of the payments to be made by the Procuring Entity to the Service Provider as hereinafter mentioned, the Service Provider hereby covenants with the Procuring Entity to supply and deliver fifty five (55) units of Brand New Photocopying Machines through a lease agreement and to remedy defects therein in conformity in all respects with the provisions of the Contract.

under the provisions of the contract at the time and in the manner prescribed by the contract. In case of delays in the delivery/performance of the required services specified in this Contract due to the Service Provider's fault, the Procuring Entity shall deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one percent of the cost of the unperformed portion for every day of delay until actual delivery or performance. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum is reached, the Procuring Entity may rescind the contract pursuant to GCC Clause 23, without prejudice to other courses of action and remedies open to it.
