BIDS AND AWARDS COMMITTEE (PRIMARY) RESOLUTION NO. 11, SERIES OF 2018

RESOLUTION RECOMMENDING FAILURE OF THE SECOND RE-BID AND THE CONDUCT OF NEGOTIATED PROCUREMENT FOR THE PROCUREMENT OF CONSULTING SERVICES FOR THE DAR-ITALIAN ASSISTANCE TO AGRARIAN REFORM COMMUNITY DEVELOPMENT SUPPORT PROGRAM- LOCAL PARTNER MICRO-FINANCE INSTITUTION (IARCDSP-Local MFI) REFERENCE: PBD-18-03

WHEREAS, the Department of Agrarian Reform (DAR), through the Loan Proceeds from the Italian Government MAECI-AICS and the Government of the Philippines (GOP) counterpart funds intends to apply the sum of Philippine Pesos Fifty Million Only (Php 50,000,000.00), being the Approved Budget for the Contract (ABC), inclusive of taxes, to payments under the contract for the procurement of Consulting Services-Local Partner Micro-Finance Institution (MFI) for the Italian Assistance to the Agrarian Reform Community Development Support Program (IARCDSP);

WHEREAS, on June 15, 2018, the DAR- Bids and Awards Committee (Primary) advertised/posted a Request for Expression of Interest (REI) in the Philippine Daily Inquirer (PDI) and the Philippine Government Electronic Procurement System (PhilGEPS) and the DAR websites, inviting qualified consulting firms for the provision of consulting services- Local Partner Micro-Finance Institution (MFI) for the Italian Assistance to the Agrarian Reform Community Development Support Program (IARCDSP) (refer to **ANNEX "A"** for the copy of PDI advertisement and PhilGEPS posting);

WHEREAS, on June 25, 2018, upon the deadline of submission of eligibility documents, only one (1) firm, Social Enterprise Development Partnership, Inc. (SEDPI), submitted its eligibility documents (refer to **ANNEX "B"** for the Attendance Sheet);

WHEREAS, in compliance with the Memorandum of Understanding (MOU) between the GOP and the Italian Government MAECI-ICS, at least three (3) firms are required to be shortlisted to proceed with the

procurement process (refer to **ANNEX "C"** for the excerpt of the said MOU); and

WHEREAS, the aforementioned requirement was explicitly stated under item no. 7 of the Request for Expression of Interest.

NOW, THEREFORE, for and in consideration of the foregoing premises, the herein BIDS AND AWARDS COMMITTEE (BAC) - Primary **RESOLVES**, as it is hereby **RESOLVED**:

1. The declaration of failure of the second re-bid; and
2. The submission to the Italian Embassy, through the end-user, a report on the outcome/ result of the eligibility documents' submission; and
3. Conduct of Negotiated Procurement as provided for in Section 53.1 of the IRR of RA 9184, following the guidelines and procedures set forth under Annex H. Consolidated Guidelines for the Alternative Methods of Procurement.
