**RESOLUTION No. 25 Series of 2017**

**RESOLUTION RECOMMENDING FAILURE OF BIDDING FOR THE PROCUREMENT OF  
(LOT 1) LAPTOP COMPUTERS WITH PRINTERS, (LOT 2) TABLETS, AND (LOT 3) PRINTERS FOR THE  
DAR-ITALIAN ASSISTANCE TO AGRARIAN REFORM COMMUNITY DEVELOPMENT SUPPORT  
PROGRAM (IARCDSP)**

**WHEREAS**, the Department of Agrarian Reform (DAR), through the Loan Proceeds from the Italian Government MAECI-AICS and the GOP counterpart funds intends to apply the sum of Two Million One Hundred Twenty Six Thousand Pesos (Php 2,126,000.00), being the Approved Budget for the Contract (ABC), inclusive of taxes, to payments under the contract for the procurement of (1) 33 sets of Laptop Computers with multi-function printer, (2) 28 units tablets, and (3) 26 units multi-function printers for the Italian Assistance to the Agrarian Reform Community Development Support Program (IARCDSP).

**WHEREAS**, on October 7, 2017, the Department of Agrarian Reform-Bids and Awards Committee (DAR-BAC) posted an Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS) and DAR websites on the same date, inviting qualified suppliers for the supply of Lot 1 - 33 units of Laptop Computers with multi-function printers; Lot 2 - 28 units of tablets; and Lot 3- 26 units of multi-function printers (refer to Annex A for the PHILGEPs posting);

**WHEREAS**, on October 30, 2017, upon the deadline of submission of bids, only one (1) bidder, Bits of Technology submitted a bid (Refer to Annex B for the Attendance Sheet);

**WHEREAS**, in compliance with the Memorandum of Understanding between the Government of the Philippines and the Italian Government MAECI-AICS, at least three (3) eligible bidders are required to participate to proceed with the procurement process (refer to Annex C for the excerpt of the said MOU);


**WHEREAS**, the aforementioned requirement was explicitly stated under Clause 30.3 (e) of the Instructions to Bidders which is found in the Bid Data Sheet(BDS) of the Philippine Bidding Documents issued (refer to Annex D for a copy of the portion of the BDS);


**WHEREFORE**, premises considered, the BAC resolved to recommend to the Head of the Procuring Entity (HOPE) the following: (1) declaration of bid failure; (2) conduct of mandatory review of the technical specifications, Approved Budget of the Contract (ABC), and other Terms and Conditions to determine the cause of bid failure; and (3) conduct a rebid once the mandatory review is completed.


