**RESOLUTION RECOMMENDING THE AWARD OF CONTRACT  
TO: *SOCIAL ENTERPRISE DEVELOPMENT PARTNERSHIPS,  
INC.(SEDPI)* FOR THE PROVISION OF CONSULTING  
SERVICES UNDER THE ITALIAN ASSISTANCE TO AGRARIAN  
REFORM COMMUNITY (ARC) DEVELOPMENT SUPPORT  
PROGRAM (IARCDSP)-LOCAL PARTNER MICRO FINANCE  
INSTITUTION**

**WHEREAS**, the Department of Agrarian Reform (DAR), in its continuing effort to pursue the government's goal to alleviate poverty, contribute to the acceleration of the peace process and improve the living conditions of households of the Agrarian Reform Beneficiaries (ARBs) in the provinces of Sarangani and Sultan Kudarat in Region XII\* and the provinces of Maguindanao and Lanao del Sur in the Autonomous Region in Muslim Mindanao (ARMM), the Government 4 of the Philippines through the DAR is implementing the "Italian Assistance to ARC Development Support Program" (IARCDSP) funded through a Loan Agreement executed with the Government of Italy;

**WHEREAS**, to ensure successful implementation of the IARCDSP, the DAR shall procure Consulting Services which comprise of the Italian Technical Assistance (ITA) and Local Partner-Micro Finance Institution, for the implementation of the Micro Finance sub-component of the project to promote sustainable production increases, agricultural diversification and a real increase in income to farmers;

**WHEREAS**, the BAC, through BAC Resolution No. 23, Series of 2018, recommended to the Head of the Procuring Entity (HOPE) the approval of the final evaluation result (combined technical and financial evaluation rating) and the conduct of negotiation meeting with the Single Rated Bidder (SRB), Social Enterprise Development Partnerships, Inc.(SEDPI), subject to the SRB's acknowledgement and acceptance of the correction in the errors in arithmetical computation of the Total Bid Price from Php48,765,000.00 to

Php40,857,040.00 (Refer to Annex "A" copy of BAC Resolution No. 23 Series of 2018);

**WHEREAS**, upon approval by the HOPE of the abovementioned BAC Resolution, the Bids and Awards Committee-Technical Working Group (BAC-TWG) for this particular procurement conducted negotiation meetings with Social Enterprise Development Partnerships, Inc.(SEDPI) on October 9 & 23, 2018, with the following agreements:

1. The final figure for the remuneration of experts shall be corrected using the required number of man-months (24mm) based on the Terms of Reference (TOR) with no changes in the proposed rates;
2. The corrected Total Bid Price as re-evaluated inclusive of taxes shall be Php47,145,000.00;
3. Payment shall be in eight (8) tranches, the percentages of which will be specified in the contract agreement; and
4. Additional inputs to be provided by SEDPI such as the computer sets, seed capital of Php50,000.00, and the provision of Php5 million credit fund for the 35 ARBOs shall be incorporated in the contract;

**WHEREAS**, on October 29, 2018, the BAC -TWG presented to the BAC-Primary the above agreements and after deliberation, the BAC-Primary decided to concur with the agreements and instructed the BAC-TWG to proceed with the post-qualification evaluation of SEDPI, the SRB (Refer to Annex "C" minutes of October 29, 2018 BAC meeting);


**WHEREAS**, on November 5, 2018, the BAC-TWG conducted post-qualification evaluation of SEDPI, and on November 6, 2018 reported to the BAC-Primary the findings that SEDPI was found to have complied with all the requirements of the bidding documents, thus SEDPI was declared to be the Single Rated Responsive Bidder (SRRB) (Refer to Annex "D" Post-qualification Evaluation Report);

**WHEREFORE**, premises considered, the BAC RESOLVES to recommend to the Head of the Procuring Entity the award of contract, subject to the issuance of Agency for the Italian Cooperation (AICS) of the No Objection Declaration (NOD2) for the Provision of Consulting Services under the Italian Assistance to Agrarian Reform Community Development Support Program (IARCDSP)-Local Partner Micro Finance Institution to the SRRB, **Social Enterprise Development Partnerships, Inc.(SEDPI)** in the Total Contract Amount of



**Philippine Pesos Forty Seven Million One Hundred Forty Five Thousand Only (PhP47,145,000.00) inclusive of taxes.**




