RESOLUTION NO. 14 SERIES OF 2019

RESOLUTION RECOMMENDING: FAILURE OF BIDDING AND CONDUCT OF REBID FOR THE LEASE OF FIFTY FIVE (55) UNITS OF DIGITAL PHOTOCOPYING MACHINES FOR THE DEPARTMENT OF AGRARIAN REFORM (DAR) FOR CY 2019

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos Two Million Four Hundred Thirty Nine Thousand Five Hundred only (₱2,439,500.00) being the Approved Budget for the Contract (ABC), for the procurement of Lease of Fifty Five (55) units of Digital Photocopying Machines for CY 2019 for a period of ten (10) months;

WHEREAS, on March 11, 2019, during the deadline for submission and opening of bids, only one (1) bidder submitted its bid which was declared as the Single Calculated Bid (SCB) for having passed the eligibility check conducted by the Bids and Awards Committee (BAC)-Primary (refer to Annex "A" Abstract of Bids);

WHEREAS, on March 27, 2019, the BAC-Technical Working Group (TWG) conducted a detailed evaluation of the technical and financial bid submission bid of the SCB and found that it failed to fully comply with the technical documents submission as reflected in the BAC-TWG Evaluation Report (refer to Annex "B" Detailed Evaluation Report);


WHEREAS, on April 3, 2019, the BAC-TWG reported to the BAC-Primary its findings and recommended the disqualification of the SCB which was approved and the BAC-Primary resolved to notify the SCB of its disqualification (refer to Annex "C") Notice of Disqualification sent to the SCB-Data Images Plus Automation, Phils., Inc.);

WHEREAS, on April 5, 2019, the SCB received the notice of disqualification and did not file any motion for reconsideration (refer to Annex "D" receiving copy of the Notice of Disqualification);


NOW THEREFORE, premises considered, the BAC-Primary resolved in its meeting on April 15, 2019 to recommend to the Head of the Procuring Entity (HOPE) the failure of the March 11, 2019 bidding and the conduct of rebidding.




