RESOLUTION NO. 17 SERIES OF 2019

RESOLUTION RECOMMENDING ANOTHER ONE (1) MONTH EXTENSION (June 1-30, 2019) OF THE CY 2018 CONTRACT FOR THE LEASE OF THIRTY SEVEN (37) UNITS OF DIGITAL PHOTOCOPYING MACHINES FOR THE DEPARTMENT OF AGRARIAN REFORM (DAR)

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos One Million Seven Hundred Seven Thousand Six Hundred Fifty only (P1,707,650.00) being the Approved Budget for the Contract (ABC), for the procurement of Lease of Fifty Five (55) units of Digital Photocopying Machines for CY 2019 for a period of seven (7) months;

WHEREAS, the existing contract of the current service provider was already extended for another one (1) month for April 1-30, 2019 (please refer to Annex "A" BAC Resolution No. 11 series of 2019);

WHEREAS, on April 15, 2019, during the meeting of the BAC-Primary, it was resolved to declare the failure of the re-bid for this procurement and recommend to the Head of the Procuring Entity (HOPE) the conduct of another rebid, with the deadline for submission of bids to be scheduled on May 6, 2019;

WHEREAS, on April 29, 2019, during the meeting of the BAC-Primary, the end-user representative requested for an extension of the lease contract of the current service provider for the Lease of Thirty Seven (37) units of Digital Photocopying Machines for another month (May 1-31, 2019);

WHEREAS, on May 6, 2019, the deadline for submission of proposals, no bid was received by the BAC-Primary resulting to failure of the 2nd re-bid, and by the end-user's recommendation to conduct another rebid and extension of contract for another month (June 1-30, 2019) of the existing service provider;

WHEREAS, the current service provider has not violated any of the provisions of its original contract and DAR has complied with the general conditions for extension enumerated in the Revised Guidelines on the Extension of Contracts for General Support Services, Appendix 24 of the Revised Implementing Rules and Regulations of Republic Act 9184;

NOW THEREFORE, premises considered, and due to time constraints, in order to maintain status quo in the operations of the DAR and avoid interruption of said service, the BAC-Primary resolved in its meeting on May 6, 2019 to recommend to the Head of the Procuring Entity (HOPE), the extension of the contract of the existing service provider, U-bix Corporation for another month, i.e. from June 1 to 30, 2019.
