### RESOLUTION NO. 20 SERIES OF 2019

#### **RESOLUTION RECOMMENDING FAILURE OF THE SECOND RE-BID FOR THE PROCUREMENT OF LEASE OF FIFTY-FIVE UNITS OF DIGITAL PHOTOCOPYING MACHINES FOR DARCO FOR CY 2019 AND THE CONDUCT OF ALTERNATIVE MODE OF PROCUREMENT (NEGOTIATED PROCUREMENT AFTER TWO BID FAILURES)**

**WHEREAS**, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos One Million Four Hundred Sixty Three Thousand Seven Hundred only (P1,463,700.00) being the Approved Budget for the Contract (ABC), for the procurement of Lease of Fifty Five (55) units of Digital Photocopying Machines for CY 2019 for a period of six (6) months;

**WHEREAS**, on May 7, 2019, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC) posted the Invitation to 2<sup>nd</sup> Re- Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6179292 (refer to Annex "A", copy of PhilGEPs posting);

**WHEREAS**, on May 27, 2019, the deadline for submission of proposals, no bid was received by the BAC-Primary resulting to failure of the 2<sup>nd</sup> re-bid, with the end-user recommending the resort to Alternative Mode of Procurement: Negotiated Procurement because of two (2) bid failures;

**NOW THEREFORE**, premises considered, and due to the absence of interested bidders for two (2) consecutive re-bids, the BAC-Primary resolved in its meeting on May 27, 2019 to recommend to the Head of the Procuring Entity (HOPE), the following:

1. Declaration of failure of the 2<sup>nd</sup> re-bid;
2. Adoption of the Alternative Mode of Procurement: Negotiated Procurement because of two bid failures; and

3. Conduct of mandatory review of the terms and conditions, technical specifications, and schedule of requirements to address the possible causes of bid failures.
