RESOLUTION NO. 21 SERIES OF 2019

RESOLUTION RECOMMENDING FAILURE OF THE NEGOTIATED PROCUREMENT AFTER TWO BID FAILURES FOR THE LEASE OF FIFTY-FIVE UNITS OF DIGITAL PHOTOCOPYING MACHINES FOR DARCO FOR CY 2019 AND THE CONDUCT OF 2ND NEGOTIATED PROCUREMENT

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos One Million Four Hundred Sixty Three Thousand Seven Hundred only (₱1,463,700.00) being the Approved Budget for the Contract (ABC), for the procurement of Lease of Fifty Five (55) units of Digital Photocopying Machines for CY 2019 for a period of six (6) months through Negotiated Procurement as per BAC Resolution No. 20, series of 2019 dated May 27, 2019 (refer to Annex "A", copy of BAC Resolution);

WHEREAS, on June 15, 2019, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC) posted the Invitation to Negotiated Procurement in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6253510 (refer to Annex "B", copy of PhilGEPs posting);

WHEREAS, on June 24, 2019, the schedule for Negotiation Conference and deadline for submission of proposals, no bid was received by the BAC-Primary resulting to failure of the Negotiated Procurement, the BAC re-scheduled a meeting on June 28, 2019 pending the issuance of the Special Order for the reconstitution of the BAC;

NOW THEREFORE, premises considered, and due to the absence of interested bidders for the Negotiated Procurement, the BAC-Primary resolved in its meeting on June 28, 2019 to recommend to the Head of the Procuring Entity (HOPE), the following:

1. Declaration of failure of the Negotiated Procurement;
2. Reposting of the Invitation for Negotiated Procurement because of two bid failures with the schedule of Negotiation

Conference and deadline of submission of proposals on July 8, 2019; and

3. The extension of contract of the existing Service Provider, Ubix Corporation, for another month, for the period July 1-31, 2019.
