### RESOLUTION NO. 22 SERIES OF 2019

#### RESOLUTION RECOMMENDING FAILURE OF THE 2<sup>nd</sup> NEGOTIATED PROCUREMENT AFTER TWO BID FAILURES FOR THE LEASE OF FIFTY-FIVE UNITS OF DIGITAL PHOTOCOPYING MACHINES FOR DARCO FOR CY 2019 AND THE CONDUCT OF 3<sup>rd</sup> NEGOTIATED PROCUREMENT

**WHEREAS**, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos One Million Two Hundred Nineteen Thousand Seven Hundred Fifty only (₱1,219,750.00) being the Approved Budget for the Contract (ABC), for the procurement of Lease of Fifty Five (55) units of Digital Photocopying Machines for CY 2019 for a period of five (5) months through Negotiated Procurement as per BAC Resolution No. 21, series of 2019 dated June 28, 2019 (refer to Annex "A", copy of BAC Resolution);

**WHEREAS**, on June 29, 2019, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC) posted the Invitation to Negotiated Procurement in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6284027 (refer to Annex "B", copy of PhilGEPS posting);

**WHEREAS**, on July 8, 2019, the schedule for Negotiation Conference and deadline for submission of proposals, no bid was received by the BAC-Primary resulting to failure of the Negotiated Procurement;

**WHEREAS**, in the same meeting, the PBAC deliberated whether to extend the 2018 contract of the service provider for a period of five (5) months due to the 2<sup>nd</sup> failure of Negotiated Procurement (NP) or re-post for the 3<sup>rd</sup> time the invitation for NP;

**WHEREAS**, the PBAC decided to re-post the invitation for negotiated procurement for the 3<sup>rd</sup> time;

**NOW THEREFORE**, premises considered, and due to the absence of interested bidders for the 2<sup>nd</sup> Negotiated Procurement, the BAC-Primary

resolved in its meeting on July 8, 2019 to recommend to the Head of the Procuring Entity (HOPE), the following:

1. Declaration of failure of the 2<sup>nd</sup> Negotiated Procurement;
2. Reposting of the Invitation for Negotiated Procurement for the 3<sup>rd</sup> time; and
3. The extension of contract of the existing Service Provider, Ubix Corporation, for another month, for the period August 1-31, 2019.
