RESOLUTION NO. 25 SERIES OF 2019

RESOLUTION RECOMMENDING FAILURE OF THE 3rd NEGOTIATED PROCUREMENT AFTER TWO BID FAILURES FOR THE LEASE OF FIFTY-FIVE UNITS OF DIGITAL PHOTOCOPYING MACHINES FOR DARCO FOR CY 2019 AND THE CONDUCT OF 4th NEGOTIATED PROCUREMENT

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos Nine Hundred Seventy Five Thousand Eight Hundred only (₱975,800.00.00) being the Approved Budget for the Contract (ABC), for the procurement of Lease of Fifty Five (55) units of Digital Photocopying Machines for CY 2019 for a period of four (4) months through Negotiated Procurement as per BAC Resolution No. 22, series of 2019 dated July 8, 2019 (refer to Annex "A", copy of BAC Resolution);

WHEREAS, on August 1, 2019, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC) posted the Invitation to Negotiated Procurement in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6362045 (refer to Annex "B", copy of PhilGEPs posting);

WHEREAS, on August 9, 2019, the schedule for Negotiation Conference and deadline for submission of proposals, no bid was received by the BAC-Primary resulting to failure of the Negotiated Procurement;

WHEREAS, the PBAC decided to re-post the invitation for negotiated procurement for the 4th time in the absence of the Government Procurement Policy Board's (GPPB) response to the query of the department dated 11 July 2019, regarding extension of the 2018 contract of Ubig Corporation until December 31, 2019 (refer to Annex "C", letter to GPPB);

NOW THEREFORE, premises considered, and due to the absence of interested bidders for the 3rd Negotiated Procurement, the BAC-Primary resolved in its meeting on August 9, 2019 to recommend to the Head of the Procuring Entity (HOPE), the following:

1. Declaration of failure of the 3rd Negotiated Procurement;
2. Reposting of the Invitation for Negotiated Procurement for the 4th time; and
3. The extension of contract of the existing Service Provider, Ubix Corporation, for another month, for the period September 1-30, 2019.
