### RESOLUTION NO. 68 SERIES OF 2019

#### RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF RTK FOR THE BUREAU OF LAND TENURE IMPROVEMENT (BLTI) TO GEORIGHT MATICS, INC

**WHEREAS**, the Department of Agrarian Reform under the General Appropriations Act (GAA) for 2019 intends to apply the sum of Philippine Pesos Two Million only (₱2,000,000.00), inclusive of taxes being the Approved Budget for the Contract (ABC), for the procurement of Real Time Kinematic (RTK) for the Bureau of Land Tenure Improvement (BLTI) (refer to Annex "A" copy of approved Project Proposal);

**WHEREAS**, on October 30, 2019, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6602991,(refer to Annex "B" copy of PhilGEPs posting);

**WHEREAS**, five (5) bidders acquired and paid the bidding documents fee, namely: 1) Georight Matics Incorporated; 2) Geotech Mercantile Corporation; 3) MJAS Zenith Trading; 4) Surveytech Trading; and 5) Techphil Geosolutions Company;

**WHEREAS**, on November 6, 2019, all the five (5) bidders mentioned above attended the pre-bidding conference conducted by the BAC-Primary;

**WHEREAS**, as a result of the pre-bidding conference, Supplemental Bid Bulletin (SBB) No. 1 was issued on November 11, 2019 to incorporate in the Philippine Bidding Documents some changes in Section VII. Technical Specifications to clarify questions raised by interested bidders (refer to Annex "C" copy of SBB No. 1);

**WHEREAS**, on November 18, 2019, the deadline of submission of bids, all five (5) bidders that purchased bidding documents submitted their bid proposals and the result of eligibility and preliminary check of its bid submission is shown below, (refer to Annex "D" Abstract of Bids):

**WHEREAS**, on November 25, 2019, the BAC-TWG conducted the detailed technical evaluation of the LCB and found out that the required technical specifications on pro-buoyancy and track record of five (5) years were not complied, thus a Notice of Disqualification was sent to the LCB on November 27, 2019 (refer to Annex "E" Detailed Bid Evaluation Report and "E.1" Letter to Surveytech Trading);

**WHEREAS**, on November 29, 2019, during the BAC-Primary meeting, the TWG reported that no motion for reconsideration was filed by the LCB and the 2<sup>nd</sup> LCB was evaluated and found compliant with the eligibility and technical documents to be subjected to post-qualification on December 5, 2019;

**WHEREAS**, on December 6, 2019, during the BAC-Primary meeting, the TWG reported that the 2<sup>nd</sup> LCB was subjected to post-qualification and there is a need to ascertain compliance of the offer through testing of the RTK offered on December 9, 2019;

**WHEREAS**, on December 12, 2019, the TWG reported that based on the testing conducted, the RTK offered by the 2<sup>nd</sup> LCB did not comply with the end-user's requirement on the post processing software, thus a Notice of Disqualification was sent to the 2<sup>nd</sup> LCB on the same date (refer to Annex "F" Detailed Evaluation and Post-qualification Report on the 2<sup>nd</sup> LCB and "F.1" Letter to Georight Matics, Inc.

**WHEREAS**, on December 12, 2019, Georight Matics, Inc. wrote a letter to the BAC-Primary clarifying that its offer is compliant to the requirement, thus, the BAC-Primary decided to conduct a re-testing of the RTK on December 16, 2019;


**WHEREAS**, on December 16, 2019, after the re-testing conducted, the TWG reported to the BAC-Primary that based on the clarifications and the re-

testing conducted, the TWG and end-user's representative were convinced that the RTK offered by the 2<sup>nd</sup> LCB was able to meet their requirements as clearly manifested in its Bid Price Schedule which included the post processing software in the items comprising the RTK (refer to the attached Bid Price Schedule submitted by the bidder);


**NOW THEREFORE**, premises considered, the BAC resolved to recommend to the HOPE the award of contract to the 2<sup>nd</sup> Lowest Calculated and Responsive Bidder (2<sup>nd</sup> LCRB), **Georight Matics Incorporated** for the supply and delivery of Real Time Kinematic (RTK) for the Bureau of Land Tenure Improvement (BLTI) in the total amount of **Philippine Pesos One Million Four Hundred Fifty Four Thousand only (PhP1,454,000.00)**, inclusive of taxes.




