DARRO CALABARZONAL OFFICE - BAC Resolution No. O Series of 2020

RESOLUTION RECOMMENDING THE APPROVAL OF THE ANNUAL PROCUREMENT PLAN (APP) OF THE DAR CALABARZON REGIONAL OFFICE FOR CALENDAR YEAR 2020

WHEREAS, Section 7.1 of the Implementing Rules and Regulation (IRR) of Republic Act No. 9184 provides that "all procurement should be within the approved budget of the procuring entity and should be meticulously and judiciously planned by the procuring entity concerned. No government procurement shall be undertaken unless it is in accordance with an approved Indicative Annual Procurement Plan (APP)."

WHEREAS, Section 7.2 of the IRR of the RA 9184 also provides that "The indicative APP shall bear the approval of the Head of the Procuring Entity or second ranking official designated by the Head of the Procuring Entity to act on his behalf, and must be consistent with its duly approved yearly budget";

WHEREAS, Section 7.3.2 of the IRR of the RA 9184 also provides that "The end-user units of the procuring entity shall prepare their respective PPMP for their different programs, activities and projects";

WHEREAS, Section 7.4 of the IRR of RA 9184 provides that the "updating of the PPMPs shall be the responsibility of the respective end-user units of the Procuring Entities, while the consolidation of these PPMPs into an APP shall be lodged with the BAC Secretariat, subject to approval of the Head of the Procuring Entity";

WHEREAS, Section 7.4 of the IRR of RA 9184 further provides that "updating of the individual PPMPs and the consolidated APPs for each procuring entity shall be undertaken every six (6) months or as often as may be required by the Head of the Procuring Entity;

WHEREFORE, premises considered, the BAC resolves to recommend to the Head of the Procuring Entity, the approval of the indicative PPMPs submitted by the different end-user units of the DAR-Calabarzon Regional office which were consolidated by the BAC Secretariat into an APP for Calendar Year 2020 in the amount of Philippine Pesos Twenty Million Seven Hundred Ninety Seven Thousand Pesos Only (PhP20,797,000.00)
