## **BIDS AND AWARDS COMMITTEE-PRIMARY BAC RESOLUTION NO. 66 SERIES OF 2019**

### **RESOLUTION RECOMMENDING FAILURE OF RE-BID FOR THE UPGRADING AND REFURBISHING OF THE OSEC BOARDROOM**

**WHEREAS**, the Department of Agrarian Reform (DAR), intends to apply the sum of Philippine Pesos One Million Eight Hundred Seventy-Nine Thousand Two Hundred Only (PhP1,879,200.00) being the Approved Budget for the Contract (ABC), inclusive of taxes, to payments under the contract for the Upgrading and Refurbishing of the OSEC Boardroom;

**WHEREAS**, on November 23, 2019, the Department of Agrarian Reform-Bids and Awards Committee (DAR-BAC) posted the Invitation to Bid (re-bid) (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference no. 6687337 because of the failure of the first bidding held on November 11, 2019 (refer to **Annex "A"** copy of PhilGEPS posting);

**WHEREAS**, on December 2, 2019, the BAC-Primary conducted a pre-bidding conference which was attended by two (2) interested bidders namely: (1) CVAP Construction and (2) Intellyx IT Solutions;


**WHEREAS**, on December 9, 2019, the BAC-Primary issued Supplemental Bid Bulletin No. 1 to discuss and clarify the bidding documents issued and reply to bidders' queries raised (refer to **Annex "B"** copy of SBB No. 1);

**WHEREAS**, on December 16, 2019, the deadline of submission of bids, no bids were received based on the records of the BAC Secretariat and no bidder was present during the scheduled time of bid opening;

**WHEREFORE**, premises considered, the BAC resolved to recommend to the HOPE the declaration of failure of re-bidding and the conduct of mandatory review and evaluation of the terms, conditions, and

specifications in the bidding documents, including its ABC, should the end-user pursue this procurement in CY 2020.
