## BIDS AND AWARDS COMMITTEE RESOLUTION NO. 45, Series of 2019

### BAC RESOLUTION RECOMMENDING FAILURE OF BIDDING FOR THE UPGRADING AND REFURBISHING OF THE OSEC BOARD ROOM

**WHEREAS**, the Department of Agrarian Reform (DAR), through the 2019 General Appropriations Act (GAA), intends to apply the sum of Philippine Pesos One Million Eight Hundred Seventy-Nine Thousand Two Hundred only (PhP1,879,200.00) inclusive of taxes, being the Approved Budget for the Contract (ABC) to payments under the contract for the upgrading and refurbishing of the OSEC Boardroom of the DAR Central Office;

**WHEREAS**, on October 21, 2019, the Bids and Awards Committee (BAC) – Primary posted the Invitation to Bid (ITB) with reference number PBD-19-17 at the PhilGEPS and DAR websites (refer to Annex A for the posting at the PhilGEPS website, with reference number 6569509);


**WHEREAS**, on October 28, 2019, a pre-bid conference was held at the FAPsO Conference Room, DAR Central Office, for the purpose of addressing the queries that the bidders may have, which was attended by only one (1) bidder, AK5 Design & Technical Services (see Annex B for the bidder's attendance);


**WHEREAS**, on November 4, 2019, Supplemental Bid Bulletin (SBB) No. 1 was posted at the PhilGEPS and DAR websites to officially make clarifications on the issues and queries that were raised by the prospective bidder during the pre-bid conference (see Annex C for the SBB);

**WHEREAS**, on November 11, 2019, the BAC Secretariat, Procurement Division did not receive any bid on or before 9:00 a.m. which was the deadline for the submission of bids, and upon the schedule opening of bids at 10:00 a.m. of the same day, the BAC Secretariat reported to the BAC-Primary that no bidder submitted any bid;

**WHEREFORE**, premises considered, the BAC-Primary resolves to recommend to the HoPE, a declaration of failure of bidding for the Upgrading and Refurbishing of the OSEC Boardroom for the non-receipt of bids, and to conduct a re-bid of the same.




