WHEREAS, the DEPARTMENT OF AGRARIAN REFORM- CORDILLERA ADMINISTRATIVE REGION (DAR-CAR) through the BIDS AND AWARDS COMMITTEE advertised the Invitation for the Negotiated Procurement of Motor Vehicle (Pick-up), through an advertisement in the Philippine Government Electronic Procurement Service (PhilGEPS on January 25, 2020 with a total Approved Budget for the Contract (ABC) amounting to One Million Seven Hundred Thousand Pesos (Php 1,700,000.0);

WHEREAS, the Invitation for Negotiated Procurement was posted on January 25, 2020 at the DAR-CAR Regional Office Bulletin Board located at the 1st Floor at No. 55 Bokawkan Rd., Cor. Easter Rd., Baguio City (Please see Annex "A");

WHEREAS, the Invitation for Negotiated Procurement was posted at the Official Website of the Department of Agrarian Reform – Central Office;

WHEREAS, on the scheduled deadline for the submission of bids on 13 February 2020 at 5:00PM, only the bid of Blue Oval Automotive Corporation (Ford Metro Baguio) was received for the Negotiated Procurement of Motor Vehicle (Pick-up);

WHEREAS, during the opening of the eligibility, technical and financial documents of Ford Metro Baguio on February 14, 2020, the supplier was found to be eligible and compliant with the requirements;

WHEREAS, as per evaluation, it was determined that the bid/quotation of Oval Automotive Corporation (Ford Metro Baguio) is the Single Calculated and Responsive Bid;

WHEREAS, the bid of Oval Automotive Corporation (Ford Metro Baguio) is One Million Six Hundred Ninety Nine Thousand Pesos (Php 1,699,000.00) which is not more than the Approved Budget for Contract (ABC) of One Million Seven Hundred Pesos (Php 1,700,000.00);


WHEREAS, the BAC and Technical Working Group (TWG) conducted post qualification whereby the documents submitted by Oval Automotive Corporation (Ford Metro Baguio) were found to be eligible and compliant with the requirements;

NOW THEREFORE, we, the members of the BAC hereby resolve:

1. To declare the bid of Oval Automotive Corporation (Ford Metro Baguio) as the Single Calculated and Responsive Bid; and
2. To recommend to the Head of the Procuring Entity (HOPE), the approval and award of the contract for the Negotiated Procurement of Motor Vehicle (Pick-up) for DAR Regional Office to Oval Automotive Corporation (Ford Metro Baguio).
