Subject: SUBMISSION OF WEEKLY ACTIVITY REPORTS TO THE MINISTER

For purposes of monitoring the activities and projects of all offices within the Ministry, to keep the Minister abreast with developments relevant to program implementation, and to provide a readily available source of information for circulation to interested parties or dissemination to mass media, all concerned are hereby directed to submit, at the beginning of each working week, their respective activity reports to the Minister.

In all cases, the reports must be brief but comprehensive and shall contain facts and figures on any or all of the following (whether individual or group activities):

- 1. Highlights of the most important activity for the preceding, current, or succeeding week
- 2. Status report on special/ongoing projects or activities
- 3. Situationer on problems or projects requiring the Minister's action
- 4. Advance information on planned projects or activities
- 5. Other information of interest to the Minister and to the general public.

The reports shall be addressed to the Minister through the Chief, Public Information Division who shall be responsible in collating, analyzing, capsulizing and reproducing the reports for circulation to the Minister, Deputy Minister, Assistant Secretaries, Head Executive Assistant and all concerned or, whenever necessary and upon clearance by the Minister, cause the publication of the same in newspapers and magazines.

Activities and projects already covered by monthly, quarterly or other periodic reports are not included in this Meme Circular.
