SUBJECT: Amended Schedule of Cost for Reproduction of Aerial Photographs


For the information and guidance of all concerned, Memorandum Circular No. 4, Series of 1967, as amended, and amending Department Memorandum Circular No. 28, Series of 1973, prescribing the minimum cost per copy of reproduction of aerial photographs of areas covered by the aerial photography project of the Ministry of Agrarian Reform, is hereby amended as follows:
