

## INVITATION TO BID FOR SUPPLY AND ON-SITE DELIVERY OF AGRI-INPUTS (RICE & CORN) FOR MUNICIPALITY OF LUTAYAN UNDER ITALIAN ASSISTANCE TO THE AGRARIAN REFORM COMMUNITY DEVELOPMENT SUPPORT PROGRAM (IARCDSP) MICROFINANCE

"The Government of the Philippines (GoP) through the Department of Agrarian Reform (DAR) has availed a loan from the Italian Government MAECI-AICS towards the cost of Italian Assistance to the Agrarian Reform Community Development Support Program (IARCDSP) and it intends to apply part of the loan proceeds and GOP counterpart funds for the following goods in the amount Two Million Four Hundred Thirteen Thousand Four Hundred Eighty Eight Pesos (Php 2, 413,488.00), inclusive of taxes, being the Approved Budget for the Contract (ABC).

2. The *Department of Agrarian Reform (DAR) Sultan Kudarat* now invites bids for the supply and delivery of the above-stated goods.

Delivery of the Goods is required *Thirty (30) calendar days* upon receipt of the Notice to Proceed. The total turnover of the candidates/bidders in the last three years in the same field of the bid must be at least equivalent to the maximum budget of the contract; enterprises that have been established for less than three years may prove their economic and financial standing with any document which the contracting authority may deem. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.



- 3. The bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid should have been completed within **three** (3) years prior to the deadline for the submission and receipt of bids.
- 4. Bidding will be conducted in accordance with relevant procedures for open competitive bidding as specified in the IRR of RA 9184 (R.A. 9184), with some amendments, as stated in these bidding documents and is open to all bidders from eligible source countries as defined in the applicable procurement guidelines of the MAECI-AICS. The Total Estimated Project Cost for this project is *Two Million Four Hundred Thirteen Thousand Four Hundred Eighty-Eight Pesos (Php 2, 413,488.00)*, subdivided as follows;

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184 as amended according to the Memorandum of Understanding (MOU) signed by the Italian and Philippine Governments and specified and reflected in the Bid Data Sheet.
- 6. Interested bidders may obtain further information from the *Department of Agrarian Reform-Sultan Kudarat* and inspect the Bidding Documents at the address given below during *Monday to Friday 8:00AM to 5:00PM*
- 7. A complete set of Bidding Documents may be purchased by interested Bidders from the *BAC Secretariat* from the address below and upon payment of a non-refundable fee for the bidding documents in the amount of **Two Thousand Five Hundred Pesos (PhP 2,500.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the DAR website (<a href="http://www.dar.net">http://www.dar.net</a>) provided that bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The *Department of Agrarian Reform-Sultan Kudarat* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
