2. The *Department of Agrarian Reform (DAR) Sultan Kudarat* now invites bids for the supply and delivery of the above-stated goods.

Delivery of the Goods is required *Thirty (30) calendar days* upon receipt of the Notice to Proceed. The total turnover of the candidates/bidders in the last three years in the same field of the bid must be at least equivalent to the maximum budget of the contract; enterprises that have been established for less than three years may prove their economic and financial standing with any document which the contracting authority may deem. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II Instructions to Bidders.



- 3. The bidder's Single Largest Completed Contract (SLCC) similar to the contract to be bid should have been completed within **three (3) years** prior to the deadline for the submission and receipt of bids.
- 4. Bidding will be conducted in accordance with relevant procedures for open competitive bidding as specified in the IRR of RA 9184 (R.A. 9184), with some amendments, as stated in these bidding documents and is open to all bidders from eligible source countries as defined in the applicable procurement guidelines of the MAECI-AICS. The Total Estimated Project Cost for this project is *One Million Four Hundred Seventeen Thousand Three Hundred Seventy-Two Pesos (Php 1,417,372.00)*), subdivided as follows;

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184 as amended according to the Memorandum of Understanding (MOU) signed by the Italian and Philippine Governments and specified and reflected in the Bid Data Sheet.
