“BAC DECLARING FAILURE OF BIDDING AND APPROVING THE 2<sup>ND</sup> POSTING OF CONTRACTS UNDER IARCDSP MICROFINANCE PROJECT SPECIFICALLY SUPPLY AND ON-SITE DELIVERY OF SMALL FARM MACHINERIES SET A ((MOBILE) TRAVELLING RICE MILL W/ TRACTOR & TRAILER; CORN SHELLE; HAND TRACTOR W TRAILER; & RICE REAPER), SUPPLY AND ON-SITE DELIVERY OF SMALL FARM MACHINERIES (SET B) 4 WHEEL DRIVE TRACTOR WITH ROTAVATOR, SUPPLY AND ON-SITE DELIVERY OF SMALL FARM MACHINERIES SET C (2 UNITS COMBINE HARVESTER), SUPPLY AND ON-SITE DELIVERY OF NON-PRODUCTION INPUTS (IT EQUIPMENT), SUPPLY AND ON-SITE DELIVERY OF NON-AGRI-INPUTS, SUPPLY AND ON-SITE DELIVERY OF AGRI-INPUTS, SUPPLY AND ON-SITE DELIVERY OF AGRI-INPUTS (LIVESTOCK & POULTRY).”

WHEREAS, after few days, one of the suppliers clarified that items in Lot 2 were possibly duplicated. The BAC immediately checked the posted the documents and was found out that items were duplicated. Since there was no ample time to post the Bid Supplement, the BAC decided to cancel the 1<sup>st</sup> Posting and directed the Secretariat to repost the said contract;
