## **INVITATION TO BID FOR PROCUREMENT OF SECURITY SERVICES FOR PROJECT CONVERGE FOR CY 2021**

1. The **DAR REGIONAL OFFICE NO. X**, through the General Appropriations Act for CY 2021 intends to apply the sum of **Seven Hundred Four Thousand Five Hundred Seventy Four Pesos (P704,574.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement Security Services for Project ConVERGE for CY 2021. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **DAR REGIONAL OFFICE NO. X** now invites bids for the above Procurement Project. Delivery of the Services is required by January 1, 2021 to December 31, 2021. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Prospective Bidders may obtain further information from Ms. Ester C. Catalan, BAC Secretariat and inspect the Bidding Documents at the address given below during Mondays to Fridays, 8:00am to 5:00pm.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **October 26, 2020 until the deadline for the submission of bids** from the given address and website(s) below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of Seven Hundred (Php700.00) Pesos. The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The **DAR REGIONAL OFFICE NO. X** will hold a Pre-Bid Conference **November 3, 2020 at 10:00AM at the DAR Regional X Conference Room, Macanhan, Carmen, Cagayan de Oro City** and/or through video conferencing or webcasting via zoom, which shall be open to prospective bidders.



7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before **November 16, 2020 at 1:30pm**. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 14.
9. Bid opening shall be on **November 16, 2020 at 1:30pm** at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
10. The **DAR REGIONAL OFFICE NO. X** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
