RESOLUTION NO. 18 SERIES OF 2020

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF E-LEARNING COURSEWARE FOR THE SUPERVISORY DEVELOPMENT PROGRAM FOR DAR MUNICIPAL AGRARIAN REFORM OFFICERS (MARPOs), DIVISION CHIEFS (DCs), ASSISTANT DIVISION CHIEFS (ADCs) AND SECTION CHIEFS (SCs)

WHEREAS, the Department of Agrarian Reform under the General Appropriations Act (GAA) for 2020 intends to apply the sum of Philippine Pesos One Million Four Hundred Fifty Eight Thousand Two Hundred Forty only (₱1,458,240.00), inclusive of taxes being the Approved Budget for the Contract (ABC), for the procurement of E-Learning Courseware for DAR MARPOs, DCs, ADCs and SCs (refer to Annex "A" copy of approved Project Proposal);

WHEREAS, on September 10, 2020, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with bid ID no. 18208,(refer to Annex "B" copy of PhilGEPs posting);

WHEREAS, two (2) bidders acquired and paid the bidding documents fee, namely: 1) MYBUSYBEE, INC.; and 2) YAPSTER E-LEARNING, INC.;

WHEREAS, on September 18, 2020, only one bidder, YAPSTER E-LEARNING, INC. attended the pre-bidding conference conducted by the BAC-Primary;

WHEREAS, as a result of the pre-bidding conference, Supplemental Bid Bulletin (SBB) No. 1 was issued on September 21, 2020 to incorporate in the Philippine Bidding Documents some changes in Sections I Invitation to Bid and III Bid Data Sheet, to specify the venue for bid submission following DAR's Covid-19 protocols and additional contact number of BAC Secretariat/Procurement Division (refer to Annex "C" copy of SBB No. 1);

WHEREAS, on September 30, 2020, the deadline of submission of bids, the two (2) bidders that purchased bidding documents submitted their bid proposals and the result of eligibility and preliminary check of its bid submission is shown below, (refer to Annex "D" Abstract of Bids):
