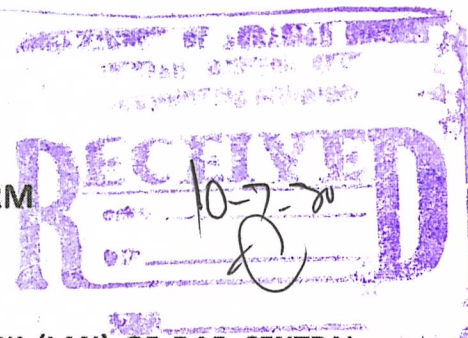

CONTRACT : UPGRADING OF THE LOCAL AREA NETWORK (LAN) OF DAR CENTRAL OFFICE TO PRONET SYSTEMS INTEGRATED NETWORK SOLUTION, INC.

CONTRACT AGREEMENT

THIS AGREEMENT made this ____ day of September 2020 between the **Department of Agrarian Reform (DAR)** of Elliptical Road, Diliman, Quezon City, Philippines, (hereinafter called "the Procuring Entity"), of the one part and **Pronet Systems Integrated Network Solution, Inc.**, of 3rd Floor, Hollywood Square Building, West Avenue Quezon City, (hereinafter called "the Service Provider") of the other part:

WHEREAS, the Procuring Entity invited Bids for certain goods and ancillary services, viz., Upgrading of DAR Central Office (DARCO) Local Area Network (LAN) and has accepted a Bid by the Service Provider to improve the performance and reliability of network services in the sum of **Philippine Pesos One Million Seven Hundred Eighty-Five Thousand (₱1,785,000.00)** inclusive of taxes;

WHEREAS, as resolved by the Bids and Awards Committee (Primary) through Resolution No. 12 series of 2020 dated July 14, 2020, **Pronet Systems Integrated Network Solution, Inc.**, is awarded the contract for Upgrading of DARCO's LAN in the sum of **Philippine Pesos One Million Seven Hundred Eighty-Five Thousand (₱1,785,000.00)** inclusive of taxes;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:


- (A) Pronet Systems Integrated Network Solutions, Inc. Eligibility Requirements, Technical and Financial Proposals;
- (B) the Schedule of Requirements;
- (C) the Technical Specifications;
- (D) the General Conditions of the Contract;
- (E) the Special Conditions of the Contract;
- (F) the Performance Security;

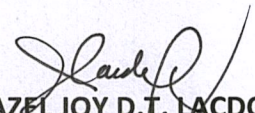

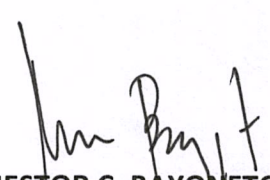
upgrade DARCO's LAN and to remedy defects therein in conformity in all respects with the provisions of the Contract.

4. The Procuring Entity hereby covenants to pay the Service Provider in consideration of the Upgrading of DARCO's LAN and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the contract. In case of delays in the delivery/performance of the required services specified in this Contract due to the Service Provider's fault, the Procuring Entity shall deduct from the Contract Price, as liquidated damages, the applicable rate of one tenth (1/10) of one percent of the cost of the unperformed portion for every day of delay until actual delivery or performance. The maximum deduction shall be ten percent (10%) of the amount of contract. Once the maximum is reached, the Procuring Entity may rescind or terminate the Contract pursuant to GCC Clause 23, without prejudice to other courses of action and remedies open to it.
