## RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROVISION OF SECURITY SERVICES CY 2021 TO TOUGH GUARD SECURITY AND INVESTIGATION AGENCY INC. AS THE LOWEST CALCULATED RESPONSIVE BIDDER

WHEREAS, the Department of Agrarian Reform MIMAROPA Regional Office, under the General Appropriations Act for 2021, intends to apply the sum of *Two Million Fifty Two Thousand Pesos* (*PhP 2,052,000.00*) being the Approved Budget for the Contract (ABC) for the provision of security services of DAR MIMAROPA Regional Office for a period of nine (9) months commencing on April 1, 2021;

WHEREAS, the DAR MIMAROPA BAC posted the Invitation to Bid for the aforementioned services at Phil-GEPs website with Ref. No. 7505784 on Mar. 02, 2021 and at DAR Official Website on Mar. 01, 2021, inviting qualified security agencies to bid for the services. Copy of Invitation to Bid is attached and marked as Annex A;

WHEREAS, issuance of bidding documents to interested bidders started on Mar. 02, 2021 where in four (4) security service providers signified interest and purchased bidding documents. The list of security service provider with expression of interest is attached and marked as Annex B;

WHEREAS, a pre-bidding conference was held on Mar. 10, 2021 to clarify certain provisions in the Instructions to Bidders, Schedule of Requirements and Technical Specifications of the Philippine Bidding Documents issued;

WHEREAS, on Mar. 22, 2021, the deadline set for bid submission, four (4) security service providers submitted their bid proposals namely: 1.) TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC., 2.) WINACE SECURITY AGENCY, INC., 3.) DARK HORSE SECURITY AGENCY and 4.) RJC SECURITY AND INVESTIGATION AGENCY, INC.;

WHEREAS, during the opening of bids, the BAC opened the first envelope (Technical component envelope) and checked the submitted documents for eligibility and technical requirements of the prospective bidders and three (3) security service providers namely: 1.) TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC., 2.) WINACE SECURITY AGENCY, INC., and 3.) DARK HORSE SECURITY AGENCY were rated as "Passed" and thereby declared eligible to bid, while RJC SECURITY AND INVESTIGATION AGENCY, INC. was declared ineligible to bid due to lacking of required documents;

WHEREAS, after determining compliance with the requirements in the first envelope, the BAC opened the second envelope (Financial component envelope) of the eligible bidders and their bids were recorded as follows:

WHEREAS, the bid of TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC. was declared as the Lowest Calculated Bid as indicated in the Abstract of Bids attached and marked as Annex C;

WHEREAS, on Mar. 26, 2021, the Bids and Awards Committee-Technical Working Group (BAC-TWG) conducted post-qualification evaluation of the Lowest Calculated Bid (LCB) to verify, validate, and ascertain the statements made and documents submitted by the bidder pursuant to Section 34 of the Implementing Rules and Regulations of R.A. 9184;

WHEREAS, the post-qualification evaluation results indicated that TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC. is responsive as per attached Post-qualification Evaluation Report marked as Annex D;

WHEREFORE, premises considered, the BAC RESOLVES to award the contract for the Provision of Security Services CY 2021 to TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC. as the Lowest Calculated Responsive Bid in the total amount of Philippine Pesos One Million Five Hundred Seventy Two Thousand Six Hundred Eleven Pesos and 49/100 (PhP 1,572,611.49).
