## RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF E-LEARNING COURSEWARE FOR THE SUPERVISORY MANAGEMENT PROGRAM (SMP) PHASES I & III

WHEREAS, the Department of Agrarian Reform under the General Appropriations Act (GAA) for 2021 intends to apply the sum of Philippine Pesos One Million Six Hundred Eighty Seven Thousand Five Hundred only (₱1,687,500.00), inclusive of taxes being the Approved Budget for the Contract (ABC), for the procurement of E-Learning Courseware for the Supervisory Management Program Phases I & III (refer to Annex "A" copy of approved Project Proposal);
