RESOLUTION NO. 26 SERIES OF 2021

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF SERVICE PROVIDER FOR THE CONDUCT OF DIGITAL COMPETENCY DEVELOPMENT PROGRAM

WHEREAS, the Department of Agrarian Reform under the General Appropriations Act (GAA) for 2021 intends to apply the sum of Philippine Pesos Three Million Three Hundred Two Thousand Five Hundred only (₱3,302,500.00), inclusive of taxes being the Approved Budget for the Contract (ABC), for the procurement of Service Provider for the conduct of Digital Competency Development Program (refer to Annex "A" copy of approved Project Proposal);

WHEREAS, on July 20, 2021, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference number 7857328, (refer to Annex "B" copy of PhilGEPs posting);

WHEREAS, on July 28, 2021, six (6) bidders attended the online pre-bidding conference conducted by the BAC-Primary thru the MS Teams, namely: 1) Assessment Analytics Inc., 2) SWISS IT Academy, Inc., 3) DDLS, 4) ENDERUN Colleges, Inc., 5) Xplore Phils., Inc., and 6) The Pros;

WHEREAS, of the six (6) interested bidders, only two (2) acquired the bidding documents and paid the bidding documents fee, namely: 1) SWISS IT Academy, Inc. JV with CALCMENU Phils. Inc.; and 2) ENDERUN Colleges, Inc.;

WHEREAS, as a result of the pre-bidding conference, Supplemental Bid Bulletin (SBB) No. 1 was issued on August 2, 2021 to provide clarifications on the queries raised by interested bidders, (refer to Annex "C" copy of SBB No. 1);

WHEREAS, on August 9, 2021, the deadline of submission of bids, the two (2) bidders that purchased bidding documents submitted their bid proposals, however, the bid of SWISS IT Academy in JV with CALCMENU Phils. Inc. was disqualified due to the absence of the required bid security in Envelope 1 (Technical Envelope), (refer to Annex "D" Abstract of Bids):



WHEREAS, on August 11, 2021, the BAC-TWG conducted the detailed technical evaluation of the SCB and reported to the PBAC on August 12, 2021 that the bid submission of ENDERUN Colleges, Inc. are in order and fully complied with the requirements of the bidding documents, hence, the PBAC directed the Secretariat to send a notice of post-qualification to the said bidder, (refer to Annex "E" Detailed Bid Evaluation Report);


WHEREAS, on August 20, 2021, the TWG conducted the post-qualification evaluation of the SCB and reported to the PBAC on August 23, 2021 that said bidder is responsive to all the requirements of the bidding documents upon validation of the documents submitted and statements made by the SCB, (refer to Annex "F" Post-qual Evaluation Report);

NOW THEREFORE, premises considered, the PBAC resolved to recommend to the HOPE the award of contract to the Single Calculated and Responsive Bidder (SCRB), **ENDERUN, Colleges, Inc.** for the conduct of Digital Competency Development Program in the total amount of **Philippine Pesos Three Million Ninety-Five Thousand only (PhP3,095,000.00)**, inclusive of all applicable taxes.
