**RESOLUTION DECLARING THE FIRST FAILURE OF BIDDING FOR THE PROCUREMENT OF
 SECURITY SERVICES AND RECOMMENDING FOR SECOND POSTING IN THE PHILGEPS**

WHEREAS, the Department of Agrarian Reform Regional Office – Cordillera Administrative Region (DARRO – CAR) through the BIDS AND AWARDS COMMITTEE openly invited Service Providers to submit bid proposals for the procurement of SECURITY SERVICES FOR CY 2022, through an advertisement in the Philgeps, in the DAR Website and official Bulletin Board of the office;

WHEREAS, four (4) bidders submitted their intention to bid;

Bidder	Remarks on the Eligibility Requirements
Ranniag Security Services	15.3 of the Bidding documents clearly state that original and copies of the bid documents shall be signed in blue ink on all pages by the bidder or the person/persons duly authorized to bind the bidder to the contract however, during the opening of the bid, it was found out that pages of the bid documents submitted were signed in black ink by the bidder or its duly authorized representative
Power Plus Security and Investigation Services Corp.	15.3 of the Bidding documents clearly state that original and copies of the bid documents shall be signed in blue ink on all pages by the bidder or the person/persons duly authorized to bind the bidder to the contract however, during the opening of the bid it was found out that not all pages were signed by the bidder or its duly authorized representative
Sidekick Force Investigation Detective Security Services Incorporated	15.3 of the Bidding documents clearly state that original and copies of the bid documents shall be signed in blue ink on all pages by the bidder or the person/persons duly authorized to bind the bidder to the contract however, during the opening of the bid not all pages were signed by the bidder or its duly authorized representative

WHEREAS, Quality Guards Services and Investigation Agency, Inc., appears to have submitted all the eligibility requirements, upon post-qualification however, it was disclosed that not all pages were signed by the bidder or the person/persons duly authorized to bind the bidder to the contract particularly;

- a. **Copy 1**, Eligibility Requirements, OR of PhilHealth contribution covering the month of January 2021;
- b. **Copy 2**, Eligibility Requirements, Page 71 of 135;
- c. **Copy 2**, SSS Remittances covering number 59-116 staff/personnel.


WHEREAS, all the bidders who participated in the bidding were determined as disqualified;






RESOLVED FURTHER, that this resolution be submitted to the Head of Procuring Entity (HOPE) for his approval.






