## RESOLUTION NO. 41 SERIES OF 2021

RESOLUTION DECLARING A FAILURE OF BIDDING AND CONDUCT OF REBIDDING FOR THE PROCUREMENT OF COURIER SERVICES FOR CY 2022 DARCO (EARLY PROCUREMENT) >

WHEREAS, the Department of Agrarian Reform under the proposed General Appropriations Act (GAA) for 2022 intends to apply the sum of Philippine Pesos One Million Two Hundred Thousand only (₱1,200,000.00) being the Approved Budget for the Contract (ABC), for the procurement of Courier Services for CY 2022 (refer to Annex "A" copy of approved project proposal);

**WHEREAS,** on December 2, 2021 the Bids and Awards Committee-Primary (PBAC) conducted a pre-procurement conference for the procurement of courier services for CY 2022;

**WHEREAS**, on December 7, 2021 the PBAC posted the Invitation to Bid in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with the deadline for bid submission set on December 29, 2021 at 9:00 a.m.;

**WHEREAS,** on December 17, 2021, at 10:00 a.m. the PBAC scheduled a virtual pre-bidding conference through MS Teams, however, there were no attendees;

**WHEREAS,** on December 29, 2021, the scheduled deadline of submission and opening of bids, no bids were received;

**NOW THEREFORE,** premises considered, the PBAC resolved to recommend to the Head of the Procuring Entity (HOPE), the following:

- 1. Declaration of failure of bidding; and
- 2. The conduct of rebidding for the subject procurement after a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates to determine the reason/s for the failed bidding.
