**A RESOLUTION ENDORSING FOR APPROVAL OF THE HEAD OF THE PROCURING
ENTITY (HoPE) OF DAR PROVINCIAL OFFICE OF TARLAC THE
ANNUAL PROCUREMENT PLAN (APP) FOR FY 2022**

BAC RESOLUTION NO. 2022-01-002

WHEREAS, in compliance with Section 7.1, Rule II of the Revised Implementing Rules and Regulations (R-IRR) of Republic Act No. 9184, the Bids and Award Committee (BAC) in coordination with the different operating units had carefully and judiciously planned and formulated the procurement requirements of the department for CY 2022 to ensure that these are reasonable and within the approved budget allocation;

WHEREAS, the end-user or implementing units have submitted their respective Project Procurement Management Plans (PPMPs) for their different programs, activities, and projects (PAPs) in accordance with Section 7.3.2 of the 2016 Revised IRR of R.A. 9184.

WHEREAS, the Annual Procurement Plan (APP) for 2022 contains the total consolidated procurement requirements of the PARO for the current year and the methods which these items are to be procured including the schedules and specific timetables of usage by respective end-users;

WHEREAS, the DARPO-TARLAC's APP for 2022 shall be submitted subsequently to the Government Procurement Policy Board (GPPB) pursuant to Section 7.2 Rule II of IRR of said act which states that, "*Section 7.2. No procurement shall be undertaken unless it is in accordance with the approved APP, including approved changes thereto. The APP must be consistent with the duly approved yearly budget of the Procuring Entity and shall bear the approval of the HoPE or second-ranking official designated by the HoPE to act on his behalf.*"

WHEREAS, the BAC in order to attain a realistic APP, had identified various supply requirements, programs and activities and its mode of procurement that will support the preparation and finalization of said indicative APP;

RESOLVED, AS IT IS HEREBY RESOLVED, that the BAC recommends to endorse for approval of the HoPE the DAR Provincial Office of Tarlac Annual Procurement Plan (APP) for FY 2022 amounting to Sixteen Million Four Hundred Sixty-Nine Thousand Six Hundred Ninety Pesos (Php 16,469,690.00).

RESOLVED FINALLY, AS IT IS HEREBY FINALLY RESOLVED, to furnish copies of this resolution upon approval of the HoPE to the Commission of Audit (COA) and GPBB for their information, guidance and reference.


