**SERVICE CONTRACT**

**THIS AGREEMENT** executed this 24<sup>th</sup> day of January 2022 between the **Department of Agrarian Reform MiMaRoPa Regional Office (DAR-MiMaRoPa)**, located at MIMAROPA Bldg., DAR Central Office Compound, Elliptical Rd., Diliman, Quezon City, Philippines, referred to as the **Procuring Entity**, represented by its Regional Director, **ATTY. MARVIN V. BERNAL** and **TOUGH GUARD SECURITY AND INVESTIGATION AGENCY, INC.**, with office address at G/F, Cavite Coliseum, Aguinaldo Hi-way, Bacoor City, Cavite, referred to as the **Service Provider** represented by herein President **LAMBERTO G. MERCADO**.

**WHEREAS**, the **Procuring Entity** needed the services of a competent and efficient security agency for CY 2022 from January 1, 2022 to December 31, 2022;

**WHEREAS**, an open and competitive bidding was conducted on the 27<sup>th</sup> day of December 2021 wherein the Service Provider emerged as the Single Calculated Responsive Bid for the provision of security services in CY 2022;

**WHEREAS**, the Procuring Entity has decided to award the contract for security services for the period January 1, 2022 to December 31, 2022 to **Tough Guard Security and Investigation Agency, Inc.**

**NOW THEREFORE THE PARTIES HEREBY AGREED AS FOLLOWS:**

1. The Procuring Entity will pay the Service Provider the sum of **PHILIPPINE PESOS Two Million Thirty Eight Thousand Nine Hundred Fifty Eight Pesos and 16/100 (PHP 2,038,958.16)** inclusive of all taxes (hereinafter called "the Contract Price") for the manpower security services;
2. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the General Conditions of the Contract;


This Contract and the Annexes set forth the entire agreement between the parties pertaining to the services described and supersedes any and all earlier verbal or written agreements pertaining to the services.
