RESOLUTION NO. 39, SERIES OF 2021

RESOLUTION RECOMMENDING THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF FARM MACHINERIES/EQUIPMENT FOR THE "CLIMATE RESILIENT FARM PRODUCTIVITY SUPPORT PROJECT (CRFPSP)" UNDER DAR'S SUPPORT SERVICES OFFICE-LOT 1: PBD-21-11

WHEREAS, the Department of Agrarian Reform through the Office of the Undersecretary for Support Services intends to apply under the General Appropriations Act (GAA) for CY 2021 the sum of Philippine Pesos Nine Million Five Hundred Thousand only (P9,500,000.00), being the Approved Budget for the Contract (ABC) for payments under the contract for the Supply and Delivery of Farm Machineries/Equipment for the "Climate Resilient Farm Productivity Support Project (CRFPSP)" under DAR's Support Services Office comprising of two (2) lots, (refer to Annex "A" copy of approved Project Proposal);

WHEREAS, on November 22, 2021, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) conducted a pre-procurement conference for the said project which was approved by DAR-BAC Primary for posting after determining that it is included in the Annual Procurement Plan (APP), the basis for the Approved Budget for the Contract (ABC) was done through a market survey and the terms and conditions and technical specifications to be incorporated in the Philippine Bidding Documents were all submitted by the end-user;

WHEREAS, on November 23, 2021, the Department of Agrarian Reform-Bids and Awards Committee-Primary (DAR-BAC Primary) posted the Invitation to Bid (ITB) in the DAR website, DAR bulletin board, and the Philippine Government Electronic Procurement System (PhilGEPS) website with reference number 8221224, (refer to Annex "B" copy of PhilGEPS posting);

WHEREAS, on December 01, 2021, six (6) prospective bidders, namely: 1) Agri Component Corporation; 2) All Certified Equipment Trading Corporation; 3) Ford Tractor; 4) Go Traktora; 5) P.I. Farm Products, Inc.; and 6) Super Trade Machinery Global, Inc., attended the online pre-bidding conference conducted by the BAC-Primary thru the Microsoft Teams;

WHEREAS, as a result of the pre-bidding conference, Supplemental Bid Bulletin (SBB) No. 1 was issued on December 07, 2021 to provide clarifications on the queries raised by interested bidders, (refer to Annex "C" copy of SBB No. 1);

WHEREAS, of the six (7) prospective bidders who attended the pre-bidding conference, only three (3) acquired the bidding documents and paid the corresponding bidding documents fee, namely: 1) All Certified Equipment Trading Corporation; 2) Agri Component Corporation; and 3) FilHolland Corporation, out of the three (3) prospective bidders who acquired the bidding documents, only two (2) submitted bids within the scheduled deadline, namely: 1) Agri Component Corporation; and 2) FilHolland Corporation;

WHEREAS, on December 14, 2021, the new deadline of submission of bids as per SBB No. 1, the two (2) bidders that purchased bidding documents submitted their bid proposals, however, the bid of Agri Component Corporation was disqualified because it failed to submit the Certification from the Manufacturer or Authorized Distributor that the spare parts will be available for the next five (5) years from end of production as required

WHEREAS, on December 17, 2021, the disqualified bidder filed a motion for reconsideration which was deliberated upon by the PBAC in its meeting on December 20, 2021 and decided to deny the same because the bidder, as authorized dealer or distributor of the farm machinery they are offering, failed to ascertain the availability of spare parts of the said machinery for the next five (5) years from end of its production, (refer to Annex "E" copy of motion for reconsideration and Annex "E.1" copy of the reply letter to the motion for reconsideration);


WHEREAS, on December 21, 2021, the TWG conducted the detailed technical evaluation of the Single Calculated Bidder (SCB) and reported to the BAC-Primary on December 22, 2021 that the bid submission of FilHolland Corporation is in order and be subjected to post-qualification evaluation (refer to Annex "F" Detailed Bid Evaluation Report of the SCB);


WHEREAS, on December 28, 2021, the TWG conducted the post-qualification evaluation of the SCB, and reported to the PBAC the result of post-qualification on December 29, 2021 which declared that the SCB is responsive to all the requirements of the bidding documents (refer to Annex "G" Notice of Post-Qualification Evaluation and Annex "G.1" Post-Qualification Evaluation Report);

NOW THEREFORE, premises considered, the BAC-Primary resolved to recommend to the HOPE the award of contract to the Single Calculated Bidder (LCB) who was declared the Single Calculated and Responsive Bidder (SCRB) for the Supply and Delivery of Farm Machineries/Equipment for the "Climate Resilient Farm Productivity Support Project (CRFPSP)" under DAR's Support Services Office-LOT 1 in the total amount of **Philippine Pesos Eight Million Seven Hundred Forty-Five Thousand only (Php 8,745,000.00)**, inclusive of all applicable taxes.






