**Procurement of 820 Units of Motorcycles**  
**(Package No. SPLIT-REF-057-PBD-22-05)**

1. The Government of the Philippines (GOP) has received a loan from the World Bank toward the cost of the Support to Parcelization of Lands for Individual Titling (SPLIT) Project, and it intends to apply part of the proceeds of this Loan to payments under the contract for the procurement of 820 units of motorcycles, broken down into three lots as follows:

Bidders can bid for one or more lots. Bids will be evaluated and awarded on lot-wise basis.

2. The Department of Agrarian Reform (DAR) now invites bids for the supply and delivery of 820 units of motorcycles. Delivery of the Goods is required not later than ninety (90) calendar days from the date of supplier's receipt of the Notice to Proceed (NTP). Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Sub-section 5, Section II. Instructions to Bidders and the corresponding World Bank Bid Data Sheet.
3. Bidding will be conducted in accordance with relevant procedures for open competitive bidding as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act", with some amendments, as stated in these Bidding Documents and is open to all Bidders from eligible source countries as defined in the applicable Procurement Regulations of the World Bank. The contract shall be awarded to the Lowest Calculated Responsive Bidder (LCRB) who was determined as such during post-qualification.
4. Interested bidders may obtain further information from Atty. Mary Mae M. Gadon, OIC-Chief of Procurement Division Office and Head, of BAC Secretariat for SPLIT Goods and Non-Consulting Services, Department of Agrarian Reform (DAR), G/F DAR Main Building, DAR Compound Elliptical Road, Diliman, Quezon City, Philippines and inspect the Bidding Documents at the said address during 8:00 A.M to 5:00 P.M.

A complete set of Bidding Documents may be acquired by interested Bidders on June 15, 2022 to July 26, 2022 from the address below and upon payment of the applicable fee for the Bidding Documents, in the amount of Philippine Pesos One Thousand Five Hundred only (PhP1,500.00).

Bid Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

5. The DAR will hold a face-to-face Pre-Bid Conference on July 1, 2022 at 10:00 a.m. at the FASPO Conference Room, Ground Floor FASPO Building, DAR Compound, Elliptical Road, Diliman, Quezon City which shall be open to all prospective bidders.
6. Bids must be duly received by the BAC Secretariat at the address below on or before July 26, 2022 at 9:00 a.m. All Bids must be accompanied by a bid securing declaration.

Bid opening shall be conducted face-to-face on July 26, 2022 at 9:30 a.m. at the FAPsO Conference Room, DAR FAPsO Building, DAR Compound, Elliptical Road, Diliman, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend. Late bids shall not be accepted.

7. The DAR reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.


