#### I. INTRODUCTION

The DEPARTMENT OF AGRARIAN REFORM (DAR) is a government agency with a mandate to lead in the implementation of the Comprehensive Agrarian Reform Program (CARP) through Land Tenure Improvement (LTI), Agrarian Justice, and Coordinated delivery of essential Support Services to client beneficiaries.

- To provide Land Tenure security to landless farmers through land acquisition and distribution; leasehold arrangements' implementation and other LTI services.
- To provide legal intervention to Agrarian Reform Beneficiaries (ARBS) through adjudication of agrarian cases and agrarian legal assistance.
- To implement, facilitate and coordinate the delivery of support services to ARBs through Social Infrastructure and Local Capability Building (SILCAB); Sustainable Agribusiness and Rural Enterprise Development (SARED); and Access Facilitation and Enhancement Services (AFAES).

#### II. PURPOSE

With this RFI, DAR is seeking feedback, innovative ideas, and solutions from the industry on how best to meet our various ICT requirements including the following:

- Upgrading of existing LAN infrastructure at DAR Central Office.
- Establishment/Upgrading of Data Center
- Hyper -Converge Servers
- Laptops
- Software

While DAR has been researching the available options in the marketplace, this RFI represents an opportunity to learn in greater detail about the capabilities of different solutions available in the industry. The result of the research conducted through this RFI will support the development of the requirements through a potential subsequent public procurement process.

## III. BACKGROUND/CURRENT STATE

The Local Area Network was established in 2013. Since then, no updates for active components were done making all of them reach their End-Of-Life support stage.

The Data Center components such as the Precision Air Condition Unit (PACU) and Uninterruptible Power Supply (UPS) are no longer functioning at their optimum performance.

The servers which were acquired in 2011 and housed at the Data Center were also within their limits and cannot meet the demand for the computing requirements of information systems being developed.

In 2020, we rehabilitated our wired LAN through the installation of 550 nodes distributed among the network users.

#### IV. REQUIREMENTS

At a minimum here are our requirements:

- For LAN Upgrading, DAR has developed the initial network design and the technical requirements.
  - Active components (UTM, switches and access points)
    - o must be suited for medium to enterprise environments, manageable
    - wireless network must be managed with wireless controller equipment with license included supporting connected wireless access points.
    - must support at least 256 VLANs
    - o must be capable of storing at least 3000 machine addresses
    - o management through a graphical user interface (GUI) and console.
    - o must not be End-Of-Life for the next 10 years.
    - Must be included in Gartner Magic Quadrant Leaders
  - LAN infrastructure
    - o interconnectivity must support full redundancy to the core switch.
    - o The existing backbone of multi-core 62.5 fiber optic cables can be utilized.

Additional details on the design and technical requirements will be provided to proponents at the appropriate phase.

- Data Center
  - Establishment of Data Center including the following components
    - PACU
    - UPS
    - Security (CCTV, Door Access Control)
    - Fire Suppression
- Hyper-Converge Servers
  - Must be included in Gartner Magic Quadrant Leaders
- Computers
  - Laptop for Power Users (Developers/Administrators)
  - o Entry-level laptops

  - Network Operating System
  - o RDBMS Software
