The Department of Agrarian Reform (DAR) has received financing from the World Bank toward the cost of the **“Support to Parcelization of Lands for Individual Titling (SPLIT) Project,”** and intends to apply part of the proceeds toward payments under the contract for the **“Procurement of 157 units Double Cabin Pick Up Vehicles broken down into three (3) Lots.”**

Bidders can bid for one or more lot(s) or any combinations of lots. Bidders shall submit its bid for all quantities and items in each lot. Evaluation and award of contract will be on a lot-wise basis.

2. The DAR now invites sealed Bids from eligible Bidders for the double cabin pick-up vehicles broken down into three lots and for delivery to Regional Offices within one hundred twenty (120) calendar days from Supplier’s receipt of Notice to Proceed, as stated in the delivery schedule Section VII.
3. Bidding will be conducted through international competitive bidding using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers -” (“Procurement Regulations”), and is open to all eligible bidders as defined in the Procurement Regulations.
4. Interested eligible Bidders may obtain further information and inspect the bidding document during office hours from 8:00 A.M. to 5:00 P.M. through OIC-Chief Procurement Division Office and Head of BAC Secretariat for SPLIT Goods and Non-Consulting Services, Department of Agrarian Reform (DAR), G/F DAR Main Building, DAR Compound, Elliptical Road, Diliman, Quezon City, Philippines.

5. The bidding document in English may be purchased by interested Bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee in the amount of PhP 1,500.00 only regardless of the number of lots to be bid. The method of payment will be Cash, Cashier's Check/Manager's Check issued by a universal, or Commercial Bank. Bid Documents will be available on October 25, 2022 until December 6, 2022. The document will be sent through e-mail ¹.

Bid Documents may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Department of Agrarian Reform will hold a Pre-Bid Conference on November 14, 2022 at 10:00 a.m. through a face-to-face conference, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before December 6, 2022 at 9:00 a.m. Late bids shall not be accepted. Bid opening will follow immediately after the deadline of submission.
8. Bids must be delivered to the address below. Electronic Bidding **will not** be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend, provided they paid the bid document fee, at the address below on or before December 6, 2022.
9. All Bids must be accompanied by a Bid Security in the form of a Bank Guarantee issued by a Universal or Commercial bank in an amount stated in the bidding document.

Attention is drawn to the Procurement Regulations requiring the Barrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
