- 2. The Department of Agrarian Reform now invites bids for Procurement of 182 units of Projectors to be distributed to various DAR Offices Nationwide (Refer to Section VI. Schedule of Requirements). Delivery of the Goods is required within sixty (60) calendar days upon receipt of the Notice to Proceed. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the Project.
